Spekhome is 'n eg Suid-Afrikaanse plant wat inheems is aan die Oos-Kaap waar olifante graag aan hul lekker blare smul. Water is ook nie 'n probleem vir die omgewingsvriendelike plantjie nie omdat hy droogtebestand is en op 250mm tot 350mm water per jaar kan oorleef en ongelooflik aanpasbaar is.
