Thabazimbi Iron Ore Mine (Pty) Ltd ("TIOM"), a full subsidiary of ArcelorMittal South Africa ("AMSA") is an established open pit operation located 220 km north-west of Johannesburg and 200 km north-west of Pretoria, in the Limpopo Province. The Mine is situated in the town of Thabazimbi. TIOM is pursuing the opportunity to process the existing D1-Old Plant Discard Dump, D2- Old Plant Discard Dump, D3 – Supply Chain Discard Dump and the existing Slimes Dams.
