Northam - Die Northam Boerevereniging – Boernor se veilingkrale is weer in volle swang, nadat die vier maande lange verbod op veilings op Maandag 17 Februarie opgehef is. Die verbod is oorspronklik ingestel as gevolg van 'n uitbreek van bek-en-klousee wat die land getref het. Boernor het heelwat spandeer om die veiling krale op te gradeer om te voldoen aan die vereistes vir Biosekerheid. Dit sluit in voetbaddens met missproeiers vir alle besoekers wat die groen area betree. Wielbaddens met sproeiers vir alle voertuie sowel as 'n veearts werkstasie met kop en lyfklampe. Ook 'n volledige stel ontsmettings kleedkamers vir persone wat met die vee werk. Daar is ook nou rooi krale wat spesifiek vir siek vee soos beeste en skape opgerig is.
