

# RUNAWAY FIRE IN ROOKUILSPRUIT

**Thabazimbi** – A runaway fire swept through Rooikuilspruit in Thabazimbi on Thursday 20 August. According to eyewitnesses, a few youngsters made a fire in the veld to cook a chicken, but things soon escalated when the fire spread through the dry veld.

The Thabazimbi Local Municipality's firefighters and Thabazimbi Crisis Control Centre (TCCC) were called to assist.

Despite the fire spreading through a large area of the veld, nobody was injured and there were no damages to the surrounding buildings.

# HELP TRACK DOWN TWO RHINO POACHERS...

A manhunt has been launched for two suspects who shot and killed two rhinos on a game farm near Swelane Village outside Phalaborwa.

One of the rhinos was killed on Monday 24 August. The other was killed the following day at a different spot on the same farm. Farmworkers found the carcass of the first rhino while patrolling the farm. Evidence gathered from that scene suggested the poachers failed to remove the horns of the rhino – it appears as if they were disturbed and ran away.

"On 25 August police were summoned to another crime scene in the same area. Upon their arrival, they discovered the carcass of the second rhino. Its horns had been removed," police spokesperson colonel Moatshe Ngoepe said. Both suspects are on the run and no arrests have been made yet.

## SASSA OPENS WINDOW FOR PAYMENT METHOD CHANGE

**SA** – The South African Social Security Agency (SASSA) will once again open its system for approved applicants to change their preferred method of payment for the special COVID-19 SRD grant.

The window period is scheduled for Monday 31 August to Sunday 06 September, 24 hours a day.

During this period, beneficiaries can change from receiving their grants at the post office to receiving them through their bank accounts. They may also change from one bank to another if they prefer to. Approved beneficiaries of the grant can change their payment method by visiting https://srd.sassa.gov.za during this period.

"When choosing a bank account, ensure that the account is in your name (SASSA cannot pay money for one person into the account held by another) and that the bank account is not closed. The payment process is delayed if money is sent to a closed account, as SASSA has to wait for the funds to be returned before sending it to the Post Office for collection," said SASSA chief executive officer Totsie Memela.

The payment of the COVID-19 grant is quicker if paid into a bank account. Applicants without bank accounts are thus encouraged to open a bank account. There are many entry-level, inexpensive options in the market – some of which can be opened online. Clients who have just been approved for the relief grant by SASSA and have received an SMS to upload and verify their bank details can do so at any time and need not wait for the window period. The sooner the details are uploaded, the quicker the payments can be made.

Any citizen who does not update their information during this window period, or who provides incorrect banking details will have the payments for the remaining months sent through to the Post Office. Responses to frequently asked questions about this relief grant can be found on the WhatsApp platform

### MAN MAULED BY LIONS

**Hoedspruit** – The Hoedspruit Police in the Mopani District are investigating the death of 69-year old lion owner Arthur Mathewson who was allegedly killed by two of his lions at the Lion Tree Game Lodge on Wednesday 26 August.

It is believed that two lionesses attacked him while they were on one of their usual walks and his wife had to no choice but to helplessly stand by and watch while he was being attacked.

According to police spokesperson brigadier Motlafela Mojapelo, police and emergency services were called to the scene. The victim was found with multiple injuries and declared dead on the scene. The lionesses have since been moved to another game lodge in the area.


