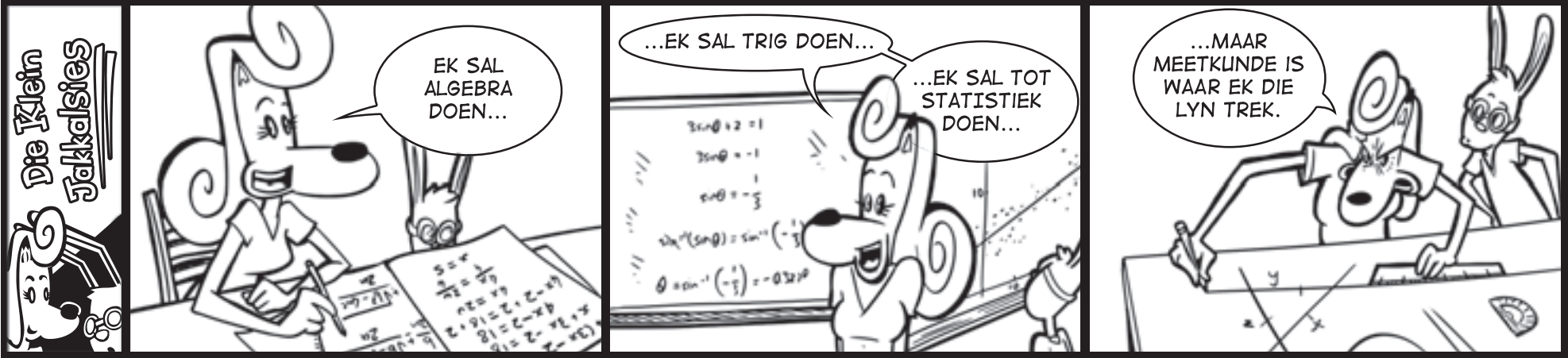

CHILD RAPIST HANDED LIFE SENTENCE

Lethabile/ Brits – A 33-year-old man was sentenced to life in prison by the Brits Regional Court on Wednesday 30 September after he was found guilty on three counts of rape.

Evidence produced in the court linked Johannes Toi Joubert to three rape incidents which occurred from May 2014 to October 2015. Joubert was arrested on Monday 3 August 2015 at his home in Lethabile outside Brits following an intensive investigation led by sergeant Boitumelo Rakabe from the Brits Family Violence, Child Protection and Sexual Offences (FCS) unit.

Before the long arm of the law caught up with him, Joubert targeted minor victims aged 8 to 16.

“As part of his method of committing the crimes, the accused hid and waited for unsuspecting school-going children in the bushy and secluded areas of Maboloka village, Centreville and Block F,” police spokesperson colonel Adèle Myburgh said. “He would then grab and verbally threaten the children before raping them. Through forensic evidence, investigators managed to link the accused to three cases that were reported from May 2014 to October 2015.”

JUSTICE FOR MURDERED FARMER’S FAMILY

Polokwane – Two of the four criminals who physically assaulted 57-year-old Hendrick Peterson on Sumadi Farm in 2017 before stealing his white Isuzu, two rifles, and other valuables, have been sentenced to a lengthy jail term by the Limpopo High Court sitting in Polokwane.

During the attack, Peterson was left severely injured after being assaulted with various objects. The farmer was certified dead upon arrival at the local hospital. On Monday 12 October, Phuti Molangoane was sentenced to life imprisonment for murder and fifteen years each for housebreaking with the intent to commit robbery and robbery with aggravating circumstances. He was further sentenced to five years imprisonment for possession of an unlicensed firearm. Both sentences will run concurrently.

Thapelo Motsamai, who was also convicted, was sentenced to 15 years imprisonment for housebreaking with intent to commit robbery as well as robbery with aggravating circumstances. The two sentences will also run concurrently. Following the death of Peterson, police immediately launched a manhunt which resulted in the arrest of four suspects a few months later.

“The fifth suspect, Phillip Modime remained on the run. During subsequent court appearances, the four accused were all granted bail. The fourth accused, who drove the stolen Isuzu, later turned into a state witness,” police spokesperson brigadier Mottafela Mojapelo said. “One of the arrested suspects, Justice Rasodi, failed to appear in court after he was released on bail. He then committed a house robbery in Seshogo and a series of other crimes while on bail. He was finally cornered in Modimolle when he was found in the company of Modime.”

A shootout ensued between the police and the suspects. Modime was fatally shot during the exchange of gunfire while Rasodi was arrested.

Rasodi will now face a series of charges ranging from murder, possession of suspected motor vehicle theft, house robbery, theft, and burglary when he appears before the court.

A PUBLIC STATEMENT FOR A PUBLIC STATEMENT

Senekal – Tying the body of the brutally killed young farm manager Brandon Horner (21) to a pole was nothing less than a public statement.

"This public statement was met by the [obvious] public statement of farmers that can no longer stand by while innocent farmers and farmworkers are killed, and that while their requests to have it declared a priority crime are falling on deaf ears," the *Platinum Weekly* was told.

A crowd of protestors showed up for the court hearing [on 6 October] of the two suspects arrested for the murder of young Brandon. The protestors forced their way into the court. At a stage one of the police vehicles was overturned. Social media is abuzz with videos of the incident.

A 52-year-old farmer has been arrested for the alleged involvement in the vandalism and damage to property and

appeared before the Senekal Magistrates' Court on 12 October. He was denied bail after making a brief appearance.

Sekwetje Isaiah Mahlamba (32), and Sekola Piet Matlaletsa (44) were arrested by Senekal detectives at Fateng Tse Ntsho in Paul Roux, Free State on Saturday 3 October. The suspects were found with bloodstained clothes and shoes, which were taken for forensic testing. The two suspects are alleged stock thieves. According to Free State police spokesperson brigadier Montantsi Makhele, Brandon was found tied up with a rope to a pole at an open space situated at De Rots - on 2 October at about 06:30. The police received a call from other farmers reporting the attack at De Rots Farm and upon their arrival, they found the body of young Brandon with injuries to his body, head and face. A knife was seized from the scene and his bloodstained Toyota Hilux was later found abandoned near Duikfontein Farm in Paul Roux.

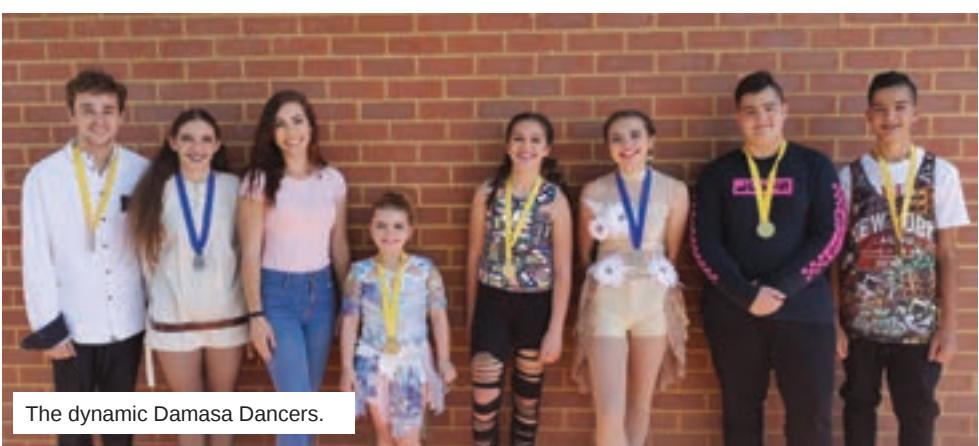
