PREPARING FOR LA NIÑA

Thabazimbi – The town of Thabazimbi is nestled between mountains and dams. Due to Thabazimbi's location, the town often fall victim to floods.

The El Niño-Southern Oscillation (ENSO) is currently in a neutral state and the forecast indicate that there is a chance that it will most likely move towards a weak La Niña state during spring and early summer in South Africa. La Niña cycles tend to bring above-normal rainfall over the summer rainfall areas of the country. The state of the surrounding dams of which most are above 70% full also increase the chances of flooding should there be an increase in rainfall.

To prepare for this potential disaster, the Thabazimbi Disaster Management Centre created a plan of action to minimise the chances and damage of potential floods. "We have started

cleaning up Rooikuitspruit and other brooks of water, to help prevent flooding," said Thabazimbi Disaster Management disaster manager Gerrie Visagie.

Once the ban on open fires has been lifted, the rest of the area will be cleaned with the assistance of Working on Fire. Previous floods were caused by overflowing dams which in turn flooded the town. Rocks rolling off the mountain because of all the rain is also a major concern.

Gerrie confirmed that if the town is not severely affected by La Niña, the town will still benefit from the precautions they have taken and should a flood occur they already have a plan in place to notify residents in case the town needs to be evacuated.

BALANCING PEOPLE, PLANET, AND PROFIT

Makhado – South African environmental scientists and non-profit organisations working in the conservation and social justice sector have been preparing submissions on the draft Environmental Impact Assessment report on the Musina-Makhado Special Economic Zone (MMSEZ), due on Thursday 22 October. South African environmental law makes provisions for the public to make comments on developments to ensure that approvals to change land use have considered people, planet, and profit. One of the objections raised is that the public participation process should not be a series of meetings in the province where people have to turn up in person, but as the impacts of this development are of national significance virtual engagements to allow broader participation is important. The draft environmental impact assessment (EIA) describes the 8,022ha MMSEZ as two townships which will flank *'predominantly heavy (noxious) industrial plants that produce various types of steel products'*, powered by an on-site coal-based power plant. Some of the submissions prepared have come from The Centre for Environmental Rights and the World Wide Fund for Nature in the Western Cape province and the University of the Witwatersrand, Endangered Wildlife Trust and Birdlife SA in Gauteng province. Environmentalists from the Bojanala District of North West province have also prepared inputs on behalf of the Magaliesberg Biosphere Reserve and the Wildlife and Environment Society of South Africa (WESSA). The botanical survey estimates that 5,657 baobab trees will be directly affected by the

MMSEZ. Not only are these iconic trees of the Limpopo province landscape, but they have untapped socio-economic value in the organic health food industry. Baobab specialist doctor Sarah Venter says that baobabs take 200 years before they produce fruit! In 2005 she started a company in Makhado to produce baobab products which sources directly from rural women and is an incentive to maintain natural habitats. This business has proven itself nationally and internationally and could be expanded in the Musina-Makhado area. Baobab trees produce a fruit that can be processed into a 'superfood' known for its unsurpassed nutritional makeup and becoming increasingly popular on the organic food market. A secondary product is a high value cosmetic oil, known as baobab seed oil. Sarah estimates that the combined value of the baobab powder and oil that can be generated from the baobab trees on the MMSEZ site alone totals R2,800,000 per annum. A second wild sourced product from the MMSEZ area are edible insects notably the popular mopane worm. The EIA process is supposed to document what occurs in an area so an educated choice can be made on gains and losses. In this instance, although the proposed project is in a district renowned for its edible insects, no mention is made in the 117-page report describing the Fauna and Flora of the area of edible insects. The poor quality of the insect investigation is evident as not a single termite species was mentioned in the report even though termite mounds are an unmistakable ever-present feature in the bushveld.

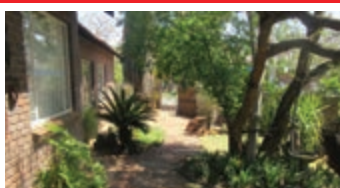

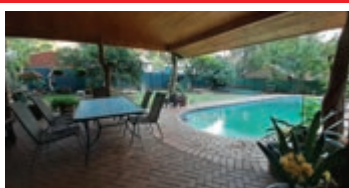

TLM PMT AND MANAGEMENT OVERSIGHT VISITS CONTINUE

Thabazimbi – The Thabazimbi Local Municipality (TLM) political management team (PMT) and municipality director conducted an oversight visit on Monday 19 October.

They visited the newly repaired Rooiberg steel reservoir whereafter they proceeded to the dwelling of a beneficiary of the new prepaid electrification project in Rooiberg informal settlement. The contractors were onsite, answering questions and providing timelines and commitments regarding the project. The delegation then paid a visit to the refurbishment of the Raphuti Oxidation Ponds, about 95% completed. To complete the project, the lining of the fourth and last oxidation pond still needs to be installed.

MAXIMUM SENTENCES FOR ANISHA AND JOEY'S KILLERS

Pretoria/ Mooinooi – The family and friends of Anisha and Joey van Nierkerk can begin to find closure after the four people who were found guilty of robbing and murdering them were handed maximum sentences by the North Gauteng Division of the High Court in Pretoria.

On Thursday 15 October, Aaron Sithole, Jack Sithole, Alex Mudau and Mercia Strydom were all handed two life sentences for murder and a further 15 years for robbery. Aaron and Jack were also sentenced to two life terms for rape while Mudau and Strydom were handed an additional six years and 20 years respectively for kidnapping. All four were also found guilty of defeating

or obstructing the administration of justice and were sentenced to a further 10 years.

The sentences will all run concurrently.

Anisha and Joey were murdered on Sunday 10 December 2017 as part of a plot by Koos Strydom to take over the couple's smallholding in Elandsfontein near Mooinooi. The two women were last seen at the smallholding on the day of the murder and their families became suspicious on 11 December after failing to locate them.

"Following a thorough investigation, Jack Sithole who was taken in for questioning together with his brother, Alex, confessed and implicated Strydom and five other individuals in the killing of the couple," said police spokesperson brigadier Sabata Mokgwabone. Koos Strydom died while in detention at the Kgosi Mampuru II Correctional Centre.

"Investigations showed that the couple was called to Koos Strydom's smallholding and forced to sign a bogus purchase agreement at gunpoint before being raped and strangled. The victims' bodies were burnt and thrown in a nearby river," Mokgwabone added.

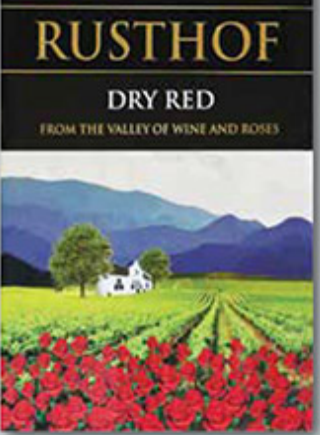
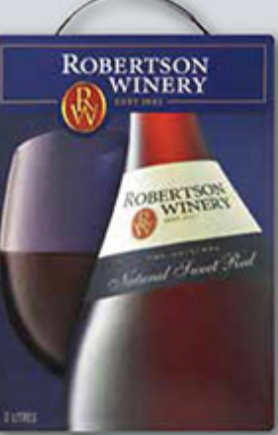
