

the Marakele National Park in Thabazimbi, was tragically killed by two young male lions on Saturday 6 March. Malibongwe Mfila, aged 27, was driving in the conservation area and left the vehicle to inspect cheetah spoor. He was a mere 10 metres from the vehicle when he was caught off guard and killed by the lions.

A passing vehicle noticed the lions devouring the deceased early on Sunday 8 March and alerted the Marakele National Park manager. Mphandeni Nthangeni and the Hoopdal police. A post-mortem on the euthanised lions revealed that they were nine months old and in poor condition. In normal circumstances, lions would remain in the pride until the age of two... but for some unknown reason, they had been abandoned by their mother two to three weeks before and struggled to feed themselves.

South African National Parks chief executive officer Fundisile Mketeni expressed his condolences to the family, friends and staff at Marataba during this difficult time. On a Facebook post the Tracker Academy paid tribute to Malibongwe who had graduated with them as a professional tracker in 2017. Marataba Safari Lodge is known for its conservation work with the Endangered Wildlife Trust (EWT), introducing a breeding population of cheetah to the Limpopo province. The project aims to counter the global threats to cheetahs from habitat loss, genetic inbreeding, and competition with humans for food. They aim to distribute offspring to other parks and reserves in southern Africa to maintain as much genetic diversity in the cheetahs as possible and to boost sustainable tourism in rural areas.

His truck had broken down just outside of town and he needs airtime to make all the necessary arrangements. Please could you send him some airtime or even pay for the damaged tyres?

This is exactly what happened to the owner of Thaba Tyres. He received a call from a man who said that his truck broke down. The man


spoke Afrikaans and asked him to just send him a large amount of airtime, because he is far from town and urgently needs to call people. He then asked him to help to get tyres on his truck. The owner arranged with another company closer to where the truck broke down to drive out and assist and made the payment for the tyres. When the other company arrived at the scene there was no truck... It was a scam.

Another creative story spun to an old age home was that the cold room had broken down and the meat needed to be donated somewhere but airtime was needed to make this possible.

Almero says that it is unbelievable how many good people are being scammed and warns that cyber crime is on the increase as this is a quick and easy way to make money or pass the time.



OF PET SCAMS! BEWARE

profiles to solicit funds from unsuspecting pet lovers. Without doing a thorough vetting of the proposed sellers and breeders, many people start by paying a deposit for a pure-bred pet that is advertised online. The prospective buyer would even receive photos on a weekly basis showing the puppy or kitten's growth thereby already

SA - Pet scams involve online users creating fake creating a relationship between pet and owner. These photos are accompanied by the demand for money, usually for immunisation or travel and delivery costs of the animal. The family intending to buy the pet which they love by this time - is eventually emotionally blackmailed by individuals capitalising on their intentions



- · The seller is not prepared to make video calls, where you must be able to see the pet with the seller on the video call. (MOST IMPORTANT)
- · The seller asks for a copy of the buyer's ID.
- » Never forward your ID to anyone requesting it for an internet sale.
- » You put yourself at risk for identity theft.
- » An ID-document is not required when buying a pet.
- · By giving your ID, you are enabling scammers to create another fake identity.
- The seller demands immediate payment and seems to be 'threatening' that the buyer might lose out on the pet as 'many' other buyers are prepared to pay immediately.
- · If there is no email on the website, refrain from continuing with the purchase.
- The "contact"-page may give another red flag if you find only a form to complete. It is not necessary for you to give any personal details when buying a pet. It is especially at this stage, the seller's responsibility to give their information to validate the sale.
- All immunisations, microchip, the cost of transport and the crate should be included in the original selling price.
- Registration fees should not be an additional requirement but also included in the original price.
- Do not fall for additional border fees. Scammers might claim the pet is detained at the border and clearance fees are payable. Do not pay any additional money.
- Scammers also create fake bank accounts. If the name of the seller does not correspond with the name of the account holder do not continue with the purchase.

Scammers play on people's ignorance with regards to COVID-19. There are no COVID-19 compliance permits necessary when buying a pet. Do not pay for it!

Animal rescue groups can also be found on the internet and are willing to help you to adopt an animal rather than to buy one from a breeder.

Thabazimbi - The Thabazimbi Local Municipality (TLM) has taken action on a letter to the editor published on 22 June 2020 in Platinum Bushvelder. The reader described the dismal state of Thabazimbi's arboretum, the potential of the site to host school fieldtrips, and to be developed as a community asset. The letter also described the then illegal activities such as illegal tree felling and dumping of rubble.

In a press statement released on Wednesday 24 February 2021, TLM says that the Arboretum Park in Hammerkop Street is a protected area in terms of section 62 and 63 of the National Forestry Act. A license or permit is required to cut, disturb, damage, destroy, or transport any indigenous tree in the arboretum. Environmental offenders can be prosecuted in terms of the act and could face a fine or three years community service.

The area has been secured with a new fence and gate and no trespassing, tree felling, or dumping will be allowed as per the Integrated Development Plan.

TLM has further committed to cutting the long grass that has grown this summer and have asked Marakele National Park to assist them in identifying and tagging protected trees.

The post on the arboretum shared on TLM's Facebook page elicited a comment that the natural area must be made available to everyone. TLM was urged to promote school field trips where indigenous knowledge and the benefits of the green areas could be shared more widely with the community.

Always worth looking TWICE AT WASPS!

Most people think of wasps as a nuisance But there are loads of factors that can when they start to build their nests under tip the balance one way or the other. Dr the eaves, but they're wrong! Wasps Patrick Kennedy a postdoctoral research are amazing! The paper wasps found in associate in the School of Biological South Africa are incredible tiny societies. If you watch them closely, you realise these societies are full of acts of selfless cooperation, internal power struggles, fascinating dominance hierarchies, and so many mysteries that we don't yet understand. Life on a wasp nest is like a mini soap opera, but one that can give us insights into big evolutionary questions such as the origin of cooperation.

We use wasps to study how 'altruism' evolves. We want to understand why a young female wasp would make the decision not to leave the family and find her own nest, but rather to stay and help rear her brothers and sisters. Biologists think this is all about helping other wasps who share the same genes and are close family to populate further than other wasp families.

Sciences, University of Bristol in the United Kingdom has chosen the Magaliesberg Biosphere Reserve to research wasps and their behaviour.

CURIOSITY COLLARED THE ELEPHANT

Zeerust – WhatsApp groups dedicated to conservation The fast response of the public private partnership in the North West province were pinging on Wednesday 10 March as wildlife vet and Tshwane University of Technology lecturer Dr Paul Bartels shared details of an elephant that had been spotted with a tyre around its neck at the Rietfontein Game Farm, north of Zeerust by he Braklaagte-Lekubu community.

Douglas Maitakhole Ramaphosa asked the question that was on everyone's mind: "How on Earth did a tractor tyre end up around an ellie's neck? How do they do that to such a big animal? I am shocked."

Bartels replied: "Hi Douglas, its them ellies themselves... playful young adults, tyres were put there long ago for erosion control and the ellies must find them interesting to occupy themselves with."

Vasti Botha and Nandi Strydom of the Department of Economic Development, Environment, Conservation and Tourism (DEDECT) commandeered Bartels from Skeerpoort to dart the elephant, local farmer Riaan van Rensburg for ground assistance, and a helicopter flown by Brits pilot and founder of Rhino 911 Nico Jacobs to assist with the elephant rescue.

was crucial as the region has been experiencing hot temperatures which could have further stressed the elephant. The tyre was preventing the elephant from flapping its large ears which help it to regulate its body temperature. This is the second incident involving an elephant and a tractor tyre since the start of the COVID-19 period.

This elephant is part of a small group of free-ranging peaceful elephants located on a community reserve. A past landowner had with all good intentions buried tractor tyres in eroded areas and filled them with rocks. The construction functioned well to dissipate the energy of stormwater and to stop the topsoil from washing away, but no one realised that over time the tyres would become a danger to wildlife.

The young elephants' insatiable curiosity was sparked when they saw something that was unfamiliar to them. They dug up the tyre and two young male elephants engaged in playfully throwing the tyre to each other. The elephant probably caught the tyre with its trunk, and it slipped around its neck.

Elephants are known as the gentle giants and now we know they are also curious and playful.
