Hy het op die muurtjie gedruk om oor te loer toe hy 'n skielike brand op sy linkerhand gevoel. Dit is immers die bosveld en met al die goggas en kreature wat deel uitmaak van dié wêreld kan mens nooit te versigtig wees nie.

Owen het dadelik in die huis ingehardloop en vir sy pa gesê dat iets hom gebyt het. Die soektog na die gevreesde knibbelaar het begin en beurtkrag het dit ook nie

Meeste mense verwys na die honderdpoot as ‘n oorkruiper – hoe daai reuse gogga in jou oor moet klim sal niemand kan verduidelik nie, maar daar is egter ‘n kleiner ses-been gogga wat eintlik oorkruipers genoem word. Moet ook nou natuurlik nie fout maak om die honderdpoot met die duisendpoot te verwar nie wat dit is ook twee heeltemal verskillende gediertes.



‘n Oorkruiper

Van kleins af het ons gehoor dat die gogga in jou oor klim en eiertjies in jou brein lê! Goeie genugtig dit is grillerig... maar dis nie waar nie! Vir ‘n insek met ‘n lyf nie groter as 3cm nie, kom hulle wel baie aggressief voor maar kan nie eers behoorlik byt nie. Hulle lewe van verrotte plantmateriaal en insekeiers en vang so af en toe ‘n klein mier om aan te peusel. Hulle het net ses pote.



‘n Honderdpoot

Alhoewel daar baie grillerige stories rondloop oor die gedierte, is meeste van die mites nie waar nie. Die spesie wat in Suid-Afrika voorkom is nie giftig vir mense nie, maar die bytplekke kan baie brand en ontsteek. Die grootste word ongeveer 260mm lank en die kleinste spesies sowat 20mm. Honderdpote het tussen sewe en 173 paar pote – altyd ‘n ongelyke getal. Hulle is roofdiere en eet graag ander insekte.



‘n Duisendpoot

‘n Duisendpoot is een van die oudste land-diersoorte op aarde. Hulle het nie regtig 1,000 pote nie maar op die meeste 680 – afhangende van die soort. Hulle vreet alles... hoofsaaklik ontbindende plantmateriaal, partykeer ook vars plante, sagte vrugte, wortels waar die plante dikwels water kry en ander insekte soos ruspes as hulle die dag lus kry.

Kies wat jy wil kies. Weét net wat jy kies!

Thabazimbi – Dwelms in Thabazimbi is ‘n realiteit. Dit is skokkend om te dink hoeveel kinders in die pragtige klein dorpie vasgevang is in die greep van dwelms.

Platinum Bushvelder het gesels met ‘n Thabazimbi gemeenskaplid (wat graag anoniem wil bly) met 30 jaar se ondervinding in rehabilitasie.

“In ons dorp het ek al dwelmgebruikers teëgekomp van so jonk as nege jaar oud en selfs ouer mense in hul sewentigs. Wat baie skokkend is, is dat heroïne baie algemeen is in die dorp – selfs onder die jongste verslaafdes,” sê ons informant. Alhoewel die gemeenskaplid nie meer aktief betrokke is by rehabilitasie nie, is daar steeds ander instansies wat meer as bereid is om te help. Hy moedig verslaafdes aan om hulp te soek by ‘n kerk en om hulself te omring met positiewe mense.

“Moenie jouself in ‘n situasie plaas waar jy weer in die versoeking kan val nie. Handhaaf die Bybel se beginsels, dis ‘n positiewe, motiverende boek. Bid elke dag en werk hard aan jou verhouding met God,” voeg hy by.

Slegs ‘n klein persentasie van verslaafdes rehabiliteer suksesvol. Rehabilitasie sentrums is baie duur en meeste van die tyd kan die persoon dit nie self bekostig nie. Organisasies en ouers kan ook nie altyd ‘n bydrae maak nie en waar moet die verslaafdes dan draai vir hulp? Dit is beter om net nooit te begin nie want om uit die kloue van verslawing te kom is baie moeiliker as wat jy ooit sou dink. Meeste kinders wat aan dwelms verslaaf raak, is as gevolg van groepsdruk van slegte vriende of ouers wat ‘n verkeerde voorbeeld stel.

Daar is ‘n tyd en ‘n plek vir alles en elke ouer het ‘n verskillende manier van hoe hy of sy hul kinders groot maak, maar hier is ‘n paar wenke indien jy vermoed dat jou kind dwelms gebruik:

- Gaan deur jou kind se tas.
- Maak seker jy weet wie jou kind se maats is, en dat hul ‘n goeie invloed op jou kind het.
- Let op as jou kind se persoonlikheid verander.
- Kyk gereeld na jou kind se pupille.
- Wees op die uitkyk vir woedeuitbarstings of as ‘n kind begin onttrek.
- Weet waar is jou kind te alle tye – dit is jou verantwoordelikheid om jou kind reg op te voed.
- Asseblief, moet nie jou kinders saamneem na ‘questionable’ kuierplekke toe nie.

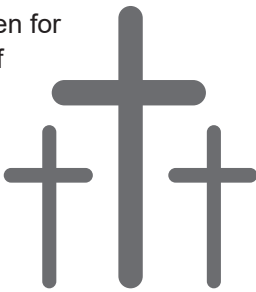
