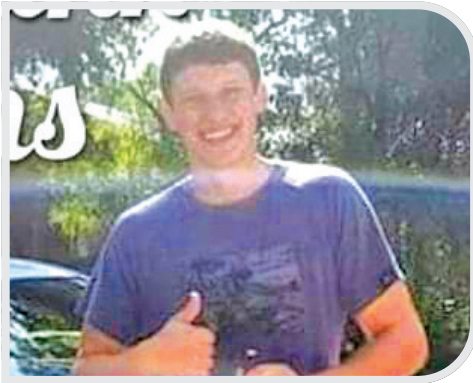

Rape suspect's bail refused



Thabazimbi—Aman accused of attacking and raping two women on Thursday 14 October will remain in police custody until he makes a third appearance before the court on 4 November. The suspect was denied bail when he appeared before the Thabazimbi Magistrates' Court on 21 October and police are conducting further investigations into the matter.

Police spokesperson constable Titus Khumalo told *Platinum Bushvelder* that the two women were attacked while returning home from a stokvel they attended at Matikiring informal settlement.

"A 58-year-old woman and a 39-year-old woman, who is eight and a half months pregnant, were attacked and raped," Khumalo said. "The victims have received medical and psychological help. The case has been referred to a higher court," he added.

South Africa: Thousands of murderers and rapists released on parole without DNA samples taken



SA – Minister Ronald Lamola recently confirmed that 96,875 prisoners, jailed for Schedule 8 offences, have been released since 2016 without a DNA sample being taken or recorded on the National Forensic DNA Database.

This is due to Minister of Police, Bheki Cele dragging his feet and neglecting to bring the Convicted Offender Amendment Bill (CO Bill) to Parliament. Murder, rape, human trafficking and sexual offences against children are all schedule 8 offences. Those released are the most violent criminals in our society. Research reveals the likelihood of these violent criminals committing another murder or rape is extremely high.

By not signing the Convicted Offenders Amendment Bill and enforcing its implementation, our government has failed in their constitutional duty to South African citizens. Therefore, Action Society with the support of DearSA, has written a letter of demand to the President, the Minister of Correctional Services and the Minister of Police, to demand the immediate implementation of the CO Bill.

Tax-paying, law abiding citizens can no longer stand by while government fails to protect the most vulnerable groups of our society and threaten our safety.

In the end, we should stop enabling them and practice tough love. We too often say: "But it's my child or it's my brother." If you really love them, you can help them by setting boundaries. Stop making excuses for them or bailing them out of trouble. Never give them cash or let them use your credit cards. Make sure that you establish a curfew and house rules because you can't allow them the dictate your schedule.

We all have choices and they have made theirs. It breaks my heart, but I know that I have done everything I possibly could to help them stay clean.

I would encourage other families out there that the moment you suspect something, to get help. In my experience, the longer they are addicted the more they struggle to stop. Educate yourself on the signs of substance abuse and look out for them. All it takes is one shot to get addicted – so please be vigilant – it can happen to anyone.

Kgosi Ramono Pilane Linchwe's property torched

Moruleng – Kgosi Ramono Linchwe of Bakgatla-Ba-Kgafela in Moruleng's property was torched on 23 October. According to a press statement issued by the Office of the Premier, an unknown group of people fought with and overpowered security at the gate, entered the homestead and torched the property. The press statement reads: 'We call upon the community of Moruleng and all the areas under Bakgatla-Ba-Kgafela Administration to work with government to restore calm in the area and assist the police to apprehend those responsible for this unfortunate incident. Those who are against peace should not be allowed to succeed. Much progress has been registered since we took over the administration of Bakgatla-Ba-Kgafela following the findings of the commission of inquiry commissioned by the Premier.'



STABBING AT FILLING STATION

Northam – A person was stabbed on Friday 22 October at an open garden near Northam filling station. A group of people gathered under the trees and were drinking when a fight broke out and a person got stabbed. Manager of Northam Filling Station Antionette Lotter told *Platinum Bushvelder* that she witnessed the incident. She expressed her concern about people regularly gathering at this spot and drinking. Sergeant Fortune Madisa from Northam Police Station said that no complaint or case was registered at the station relating to the incident. Public drinking at undesignated areas is a criminal offence and those found on the wrong side of the law risk a heavy fine or jail time.

Public drinking is not allowed at the open garden near the filling station.

Northam – A foul smell has been hanging in the air on the Swartklip road outside Northam for the past week. The smell can be attributed to a pump at the sewerage plant that broke on Wednesday 20 October. According to councillor David Gouveia, the slash pump picked up unwanted materials and pushed it through the casing, causing the pump to break. The sewerage started backing up and spilling over into the surrounding area. Northam has been struggling with blocked drains for more than a year. Thabazimbi Local Municipality (TLM) started with the process to procure a jet truck to unblock the drains about six weeks ago and last week the process finally started. Items of clothing, utensils and rocks were some of the items found in the blocked drains. With the drains slowly but surely being unblocked, some of the discarded items ended up at the plant and in the pumps. The broken pump was repaired on 27 October. "We would like to urge the community once again to not throw non-biodegradable items in the sewers. These items block the drains, causing backups and spillages. We have to look after our city and its infrastructure," TLM Northam satellite manager Fred Marirri says.

Rhinos battle Bulls for Charlton Cup glory

Northam – Northam Rhinos will be up against Midas Naka Bulls in what is expected to be an exciting final of the 2021 Charlton Cup to be held on Saturday 30 October. This hugely anticipated clash, to be played at Loftus Versfeld, will also be screened live on SABC 2 from 19:00.

Rhinos, who will be backed by thousands of rugby followers from Northam, made it to the finals by winning their semi-final match against University of Pretoria (TUKS). They hope to go a step further by lifting a very prestigious trophy in South African rugby.

Managing that achievement – however – will not be easy. Unlike Rhinos, this is not Naka's first final.

The last time the Naka Bulls made it to the finals was in 2016 when the Moot's pride lost to TUKS in the semi-finals by a 12-60 score only for the latter to be disqualified in the week of the final for transgressing the eligibility bylaws of the competition. However, Naka lost to Centurion in the final and will be very determined to go all the way this time around.

The Rhinos have already made history by making it to their first Charlton Cup final. And when the game begins, they will be just 80 minutes away from becoming the first ever champion of this competition from outside the Tshwane Region of the Blue Bulls Rugby Union (BBRU).

If they win, Rhinos will also enjoy the record of becoming the first opponents to beat TUKS three times in the same season and in the same competition – a statistic that will haunt the 2019 champions for quite a while. Rhinos thoroughly deserve to be in the finals of this competition – if their victory over TUKS can be anything to go by. Their forwards laid the foundation for that win with their physical and relentless approach to the game.

Their aggression was complimented by a formidable defensive approach with Anthony Brand, Maverick van der Merwe and Patrick Hatching ensuring that the Rhinos backline was solid and impenetrable.

Naka, on the other hand, powered to a 47-26 win over Betway Centurion to progress to the finals.
