
KEEP A CLOSE EYE YOUR KIDS



Thabazimbi - Be extra vigilant and keep a close eye on your children when you visit a mall or busy part of town, as a young mother who went for brunch with her children and her mother-in-law recently had a very unsettling experience.

"We were sitting in Wimpy at the Thaba Mall when an unknown man lifted his one leg over the railing and started calling at my three-year-old daughter to go to him," says a very upset Mariska du Toit. Being vigilant, du Toit and her motherin-law immediately picked up on his suspicious behaviour. They immediately alerted the mall security, who at the time was standing just outside Wimpy. According to Du Toit, the security officer replied: "The guy is mad." Du Toit ran after the man to confront him, who then said to her that he will take her child 'next time'.

When Platinum Bushvelder took the matter up with the mall's management, we were referred to Wimpy. We also spoke to the portfolio manager of the owners of the mall who said: "We are busy with an investigation, but ultimately we are not involved in what goes on at the Wimpy."

Speaking to the manager of Wimpy, it was clear that the safety of their customers, especially the children, is of utmost importance to them. He said that they will ask their staff to be on high alert to the surroundings and that they will also take it up with mall management. He also said that by making the railing higher, might help to prevent this type of incident and that they will look into it.

Sector head at Community Policing Forum (CPF), Petrus van Breda says that parents must keep their children close to them and that they should never let them out of their sight. "Unfortunately, we live in a country where these things happen," he says.

Thabazimbi - Specialised Security Services' Mike Bolhuis recently cautioned against an increase of pet scams on national level.

We reached out to a vet in Thabazimbi, doctor Jamiela Barnard. She also warned: "Be vigilant if you buy an animal online, do your research thoroughly and make sure of your facts; although," she added: "Even with plenty of research you can still be scammed. was scammed this way a few years ago when my friends and I wanted to purchase a Bengal cat."

Scammers' Modus Operandi (according to Bolhuis):

- Scammers will post an ad, offering a pedigree pet at an unexpectedly discounted price or even for free.
- Even if they advertise for free they often ask for only the transport, medical or insurance costs.
- Breeder and the courier services are often in cahoots.
- Often the breeder sells different kinds of breeds.
- Be careful if a breeder asks for E-wallet payments.
- Check the internet to see if the photo appears elsewhere and check if the details are the same or if it is just a stock photo they used.
- They catch you with price increases

after the deposit is paid.

- Scammers often use social media to target victims.
- The puppy is delivered at the courier services and payments are made for the crate, airline ticket, feeding and care, accommodation and insurance. Eventually, the puppy may "die" or be "locked up by customs".
- Perpetrators will even go as far as providing you with a fake address and fake invoices.

Useful tips:

- · Research the seller extensively. If you must purchase a dog online, search the seller's name and contact information with the words "scam" and "complaint" in the search.
- Since scammers are always one step ahead and change their names and the names of their websites, be aware that there may also be no negative results or complaints. Many current lists are available on the internet, highlighting new sites used by scammers.
- · Ask the seller for any references and follow up on the references.
- · Contact your local breeding society for references regarding trusted breeders.
- · Meet and collect the animal personally.

ALLEGED CHILD RAPIST'S **BAIL HEARING** ON 19 FEB

Thabazimbi – Letlhake Lebogang (21) stands on trial for two counts of rape. kidnapping and pointing a firearm.

According to police spokesperson constable Titus Khumalo, a 13- and 16-year-old were raped on 1 January. Lebogang was arrested later that same day.

Lebogang appeared before the Thabazimbi Magistrates' Court on 10 January. The case was postponed to 19 January for bail application - which was denied. Lebogang will formally apply for bail on Thursday 17 February. Investigations continue.

Constable Khumalo urged: "I implore the community to be whistle blowers and report these types of crimes to the police immediately."

Bosveld Misdaad Ondersoeke supports regional law enforcement

Modimolle / Thabazimbi – Bosveld Misdaad Ondersoeke followed up on information regarding a housebreaking case that took place during December 2021 in Modimolle, during which several items were looted.

Information was followed up along with Lephalale crime intelligence and Lephalale detective services as well as the Modimolle detective services. Two Congolese suspects were arrested in Lephalale on 13 January. Several stolen goods were seized during the arrest. The suspects were also positively linked to housebreakings in Modimolle, Lephalale and Thabazimbi.

Thabazimbi – First and foremost, thank you street. Michael street and Van der Bill street. to Platinum Bushvelder for the abundantly positive work you put in and spread around areas of Limpopo and the North West.

However, there are a few matters that need to be heard and addressed, matters that are causing upheaval in our town. One of these matters is the congestion that is caused in and around town during school drop-off and pick-up times.

At Laerskool Thabazimbi and Hoërskool Frikkie Meyer, the traffic in the mornings and afternoons is problematic. Traffic starts from 06:30 up until 07:20. This happens again from 11:30 up until 14:00 at the schools.

The traffic from Laerskool Thabazimbi affects multiple streets namely, Deena street, Naomi

Hoërskool Frikkie Meyer traffic affects 10th avenue, 13th Avenue, and Tambotie street.

The primary school makes parking available inside their premises for the parents to collect their children to ease the traffic, but a majority of the parents only make use of the drop-off space. This causes time delays, accidents waiting to happen, and rude and impatient drivers.

At the high school there is only a pick-up and drop-off zone and little parking available. The buses also need to make use of this facility to collect the students. This too causes time delays, accidents waiting to happen, and rude and impatient drivers.

Musina Ring Road to be completed by 2022

he Musina Ring Road will alleviate severe traffic congestion in the Musina central business district (CBD) once it is completed in the second quarter of 2022. A key benefit is that travel time for road users in and around Musina is expected to be significantly reduced.

The project consists of construction of approximately 8km of greenfields (new) single-carriageway freeway to form a western ring road around the town. The alignment deviates from the existing N1 section 29 alignment just south of Musina, and ties back into the existing alignment just north of the town.



Thousands of heavy vehicles use the N1 every day and pass through Musina CBD, adding to the traffic congestion and creating conflict with local traffic and pedestrians.



Project Manager Hennie Kotze said that the Musina Ring Road will facilitate mobility and safe movement of goods and services in and around the town.

"The R640 million project is progressing well. The stormwater infrastructure is complete as well as the majority of the earthworks. Except for the Nancefield interchange bridge, the other bridges are at advanced stages of completion. The contractor is currently progressing with layer works and surfacing," said Kotze.

"Apart from COVID-19-related restrictions, which are proving to be a challenge on many projects managed by SANRAL across the country, we are confident about the anticipated June 2022 completion date, provided there are no further delays," he said.

The project provides access to opportunities for local community members and small, medium and micro

enterprises (SMMEs). Fourteen targeted enterprises from the Musina municipal area are currently employed on the project.



"Up to 12% of the R640 million contract value will be allocated to targeted enterprises, of which 10% will be allocated to women-owned companies. The contractor has exceeded the 12% target and is currently standing at 14%," said Kotze.



"There is also a contractual requirement to employ local labour, often referred to as targeted labour, to the value of 6% of the contract value. Of this value, 30% each must be used on women and youth labour."

SANRAL recognises that it can help to build a capable and developmental state and drive economic development through the provision and maintenance of critical infrastructure. The Musina Ring Road project showcases this. Local businesses and communities have had access to employment through this project, as well as opportunities to tender for subcontracting.

Ensuring effective project communication

n SANRAL projects a Public Liaison Committee (PLC) is formed and a Public Liaison Officer is appointed, in order to facilitate the smooth running of the projects and effective communication.

The PLC is made up of representatives of the project's stakeholders and the affected communities. The PLC would include individuals from the following sectors:

- · Traditional leaders
- · Provincial authority
- · District authorities
- Local authorities
- Registered community-based organisations
 (e.g. road transport forums, women's organisations, and those representing persons with disabilities)
- · Safety councils, etc.
- · Department of Labour centres.

In addition, representatives from SANRAL's key stakeholders also form part of the PLC, including the Project Manager, Public Liaison Officer (PLO), engineer and route manager.

The PLC is the official communication channel between project stakeholders and affected communities, as well as for communication between them and the project team.

The main purpose of the PLC is to facilitate and oversee the processes that are happening within the project. They also ensure that everything is happening transparently. In addition, they assist in reaching out to the different constituencies to make sure the relevant information flows to the communities.

The PLO is an individual hired through a recruitment process, who is the contact person between the community and the Project Management Team (PMT). The PMT consists of the SANRAL Project Manager, the consulting engineer and the contract manager, who are service providers appointed by the roads agency.

One of the key duties expected of a PLO is securing labourers for the appointed contractor and subcontractors on a project. This is done in collaboration with the local municipality concerned and the Department of Labour. The PLO is also vital in identifying relevant training opportunities for targeted labourers.

The PLO also provides language translation services during engagements with the community. Lastly, the PLO is expected to conduct relevant stakeholder intelligence gathering within the communities concerned, and to ensure that the PMT is fully aware of this.

By establishing a PLC and appointing a PLO, SANRAL can work collaboratively with the key



communities that live along their road network – like those impacted by the Moloto Road upgrade – ensuring that all processes are fair, transparent and benefit the communities.

Three major projects for Lephalale Local Municipality

he South African National Roads Agency SOC Limited (SANRAL) recently hosted an information-sharing session in Lephalale Local Municipality to announce three projects that will create subcontracting and job opportunities.

The reseal and routine road maintenance (RRM) projects in the municipality will strengthen joint planning with the local community and small, medium and micro enterprises (SMMEs), and increase project coordination in the delivery of roads infrastructure. This will leave a legacy that extends beyond the physical roads.

"SANRAL will embark on resurfacing of the R572 national road from Monte Christo to Rooigrond and from Rooigrond to Tom Burke, and RRM of the R510 national road from Lephalale to Monte Christo, R572 from Monte Christo to Tom Burke, R518 from Lephalale to the Mogalakwena municipal boundary, and N11 from the Blouberg municipal boundary to the Groblersbrug border post," said SANRAL Northern Region project manager Nozipho Ngomane.


The second RRM project is for the R33 national road from the Modimolle municipal boundary to the R510 intersection in Lephalale, the R520 from the R510 intersection to the Modimolle

municipal boundary, and the R510 from the Thabazimbi municipal boundary to the R33 intersection in Lephalale.

The R213 million project for resurfacing of the R572 national road is expected to take 12 months to complete, and aims to employ 120 people. Work to be undertaken in terms of the contract ranges from application of temporary and permanent road markings, to repair and renewal or installation of new guardrails.

The combined value for two RRM projects covering parts of the R510, R572, R518, R33, R520 and N11 is R237 million. These projects aim to employ 200 people and are targeted at SMMEs from Lephalale Local Municipality and Waterberg Local Municipality. Work to be undertaken in terms of the contract ranges from repairing damaged road signs and pavement layers, to the construction of drainage works to combat erosion.

Local businesses and communities will be able to access employment and opportunities to tender for subcontracting. Should a sufficient number of contractors not be found in the specified target area, it will be expanded to allow sufficient participation and ensure a competitive tender process.

SANRAL projects create jobs in Makhuduthamaga

t a recent 'Taking SANRAL to the People' stakeholder engagement session in Makhuduthamaga Local Municipality, Limpopo, SANRAL Northern Regional Manager Progress Hlahla shared information about current and future projects in the area.

"Knowledge is power. When you know the projects SANRAL is working on, you can embark with us on this journey of delivering a national transport system that will ensure better roads for all South Africans," he said.

Presenting the first project, SANRAL project manager for the Northern region Ernest Ngenga said that the main contractor, Roadmac Surfacing (Pty) Ltd, has been appointed for resurfacing the R579 national road section 2 from Morwaneng to Maleetse.

"This project is valued at just above R100 million and is anticipated to start in January 2022. It will present subcontracting opportunities for grades 1 to 6

SMMEs, who will work alongside the main contractor for the 14-month duration of the project," he said.

This section of the R579 will also be upgraded. Nqenqa said that the R359 million upgrade project will start at the R33 intersection west of Morwaneng, and will end at the R579 section 3 intersection south of Maleetse. This project is anticipated to create 110 jobs for the local communities.

Presenting the third project, Ngenga mentioned that SANRAL is bringing three routine road maintenance (RRM) projects valued at R47 million to the area.

"The project includes the RRM of the N11 national road from Mookgopong municipal border through Marble Hall to Elias Motsoaledi municipal border, the R573 national road from Dr JS Moroka municipal border to Marble Hall, and the R579 national road from the Elias Motsoaledi municipal border through Nebo to the Lepelle-Nkumpi municipal border," he said.

The RRM projects will bring 12 subcontracting packages to SMMEs in Makhuduthamaga Local Municipality. SANRAL board member Thamsanga Matosa noted the concerns of the SMMEs, particularly regarding political interference in and influence over SANRAL projects.

"There are people who believe they are entitled to everything. As a result, SANRAL is losing millions of rands as this negative influence is leading to project stoppages and major project delays. We encourage the stakeholders to engage in a legal and acceptable manner that is not risky to the progress of infrastructure development in the municipality," Matosa said.

Chairman of SANRAL's board Themba Mhambi echoed Matosa's sentiments regarding political interference, and encouraged stakeholders to report, with evidence, any wrongdoing associated with SANRAL projects.







Land acquisition along the Moloto Road

ANRAL, in partnership with the Department of Rural Development and Land Reform (DRDLR), convened community resolution meetings to unlock the land acquisition process with communities of Elias Motsoaledi Local Municipality. SANRAL and the DRDLR explained the land acquisition process and how they will deal with affected community members' rights, as well as how compensation will be determined.

Officials from the DRDLR assisted by facilitating the three-day consulting sessions, as compelled by the Interim Protection of Informal Land Rights Act (IPILRA) of 1996.

Once a resolution is obtained, compensation is paid to the affected community for the underlying land, and to affected individuals where individual rights are affected.

SANRAL's project manager responsible for land acquisition on the R573 Moloto Road project, David Thubane, explained that these community resolution meetings aim to share information and update the community on developments in the land acquisition process that will be undertaken, particularly on the Moloto Road expansion project.

"Land acquisition has been a particularly emotive issue on the Moloto Road project. We therefore convened this community meeting, which took over three days, to inform these communities about the land acquisition process that we will undergo and address any concerns that they had. We reached common agreements on how we will move forward," said Thubane.

One of the key agreements reached was how local small, medium and micro enterprises (SMMEs) will benefit from the project. SANRAL always tries to ensure that local communities that live alongside its road infrastructure projects benefit. In addition to ensuring that road safety is realised and that there is seamless mobility of people on Moloto Road, SANRAL will compensate those communities who live on the road's reserve and relocate them elsewhere before expanding the road.

Thubane said that the COVID-19 pandemic has delayed these plans, as the roads agency intended to carry them out in 2020.

Encroachment on the road reserves has always been a problem, with local traders operating there, compromising road safety.

"We will continue to educate local traders and other community members about these encroachments. The road reserve has been clearly defined and marked with yellow concrete beacons in all villages along the R573, to ensure awareness of the demarcation boundaries."

SANRAL engaged with six communities over the three days: Moteti B, Slovo Village, Oorlog, Stompo Village, Waalkraal B, and Waalkraal Extension.

SANRAL's project manager on the Limpopo section of the Moloto Road, Lawrence Chauke, said it was important to engage with households and individual homeowners: "We view consultation as an important exercise for our projects to be

realised. By engaging with community members who live alongside our projects, not only do we get their buy-in on the projects, but we are also able to attend to other social issues that affect them."

Most of the communities that have achieved a community resolution will also be assisted by the DRDLR to open a Community Investment and Development Account. Through this account, funds from the land acquisition process will be allocated to further benefit community members via projects such as building a community hall, clinic, library, and other local amenities.





Meet Ernest Ngenga

Ernest Nqenqa is a Project Manager with several projects under his belt in Limpopo. He shares some insight into his role in the Northern Region.

What challenges have you encountered in your role during the COVID-19 pandemic?

Challenges during the COVID-19 pandemic are limitations when we were supposed to engage with project stakeholders. This included restricted numbers during gatherings, which affected our stakeholder engagements.

At some points when we communicate the number of people allowed to attend at the venue, some stakeholders would think that we require a certain number so that we can choose our preferred people to work on the projects.

We had to revisit how we engaged, which led to virtual meetings. Most of our stakeholders did not welcome this at first, because of issues relating to internet connectivity. Some meetings were not resolved properly at some stage due to that.

What have been highlights of your role throughout this global pandemic?

Being able to adapt to the new way of work and appreciating the virtual meetings is my highlight. I can do virtual meetings with the project team, unlike in pre-COVID times, and with other stakeholders such as the municipality and Project Liaison Committee.


When we are doing stakeholder events we can reach over and above the stakeholders we are sitting with at the venue. The COVID pandemic has taught us that often we do not have to be at the event physically. By using virtual technology most stakeholders attend our engagements while sitting at home.

How do you measure success in your role?

By achieving most of the project-related milestones I set for myself. For example, setting up a project, initiating a project, and being part of the successful procurement process of the project.

I also measure success through my ability to set up a successful stakeholder engagement approach and learn from it. Stakeholders at different corners of the country behave differently and challenge us to be proactive and adopt a different approach when dealing with situations. There is always room to learn.

Engagement is key. The more I engage the stakeholders, no matter the situation, I am able to solve problems and see positive results.



What has been your major success in your role since you joined SANRAL?

I have successfully executed more than 10 Routine Road Maintenance projects since I joined the national roads agency. SANRAL encourages learning. The Project Manager's role allows me to learn new things almost every day, particularly when I allow time to engage my stakeholders.

Tell us about major projects you are working on that are close to your heart.

The Routine Road Maintenance of national route N11 from Limpopo/ Mpumalanga border through Groblersdal to Mokopane. This project forces me to engage the stakeholders and conduct several meetings to address the challenges at hand.

Difficult projects expose a person to stakeholders that you may not have realised existed in the areas where SANRAL has projects, and engagement becomes key. When there are further project challenges in the future, you know who to call. This is something I am facing head-on.

South Africa has the 10th largest road network in the world, measuring 750,000km. The national road network which is managed by SANRAL measures 22,253 km.
