

"Spotted" hyena spotted?

Thabazimbi - Madelein Laubscher, a new resident of Thabazimbi, spotted a hyena on the Marakele Road just outside Thabazimbi on Thursday 24 March.

"It was crossing the road near Komma Nader Guest House and Kransberg Eco Park just past 6pm," she said.

Platinum Bushvelder spoke to Marakele National Park's conservation manager Tshifhiwa Mauda.

"Hyenas are roaming animals and are commonly seen in our area on farms and parks. We regularly receive messages of hyena sightings.

Did you know?

The most commonly found hyena in South Africa is the spotted hyena. The brown hyena (Hyaena brunnea) is described as the smaller and even shver hvena.

This hyena is often misunderstood. They are gentle and have strong kin bonds. Their reputation amongst farmers is often that of 'a livestock predator'. But they face a battle of survival.

Brown hyenas are also known as "strandwolves"- an Afrikaans word which directly translates to "beach wolves" in English. This is in reference to the hyena's habit of taking strolls along the beach in search of food. It is estimated that 33% of the adult brown hyena population is nomadic, of which the majority are males.

But mostly, hyenas live at dens. The communal den represents a meeting point for clan members to come together to socialise, and also the place where the clan jointly raises the cubs.

Brown hyenas are primarily a scavenging species and can walk up to 40 km per night in search of food. They are inefficient predators and food obtained by hunting is rare.

Although often undervalued and maligned, brown hyenas play an essential role as the 'cleaners' of the ecosystem; removing carcasses and carrion which might become sources for the spread of disease. Their populations continue to decline as a result of intense persecution, and this shy and elusive species will only continue to persist where their presence is tolerated, and their ecology understood.
