THE ICONIC MONKEY THORN TREE STAYS!

Thabazimbi – “Residents of Thabazimbi Municipality and Waterberg District will be thrilled to know that the iconic landmark Monkey Thorn tree (Apiesdoring) on the R510 is here to stay!

This has come about after an intense consultative process which was held between the South African National Roads Agency SOC Limited (SANRAL) and local stakeholders concerning the details of SANRAL's R510 road improvement project,” a SANRAL press release on 14 April stated.

SANRAL awarded the contract for improvements on the R510 from Thabazimbi to Bierspruit to Raubex Construction in February 2021. After setting up the PLC and completing phase 1 of the appointment of

local sub-contractors, physical work was able to commence on site on 26 August 2021.

The existing seven-meter carriageway is to be widened on both sides for the provision of a 7.4-meter-wide carriageway, a new three-meter tarred shoulder, and a 50cm gravel rounding will be constructed on each side. Starting at 6.3 km before the Bierspruit Bridge and ending at 33.4 km before Thabazimbi, the total length of the project is 27.1 km.

To the dismay of locals, initial plans to widen the road indicated that the iconic tree located at the 32,07 km mark would have to be removed. However, following intensive consultation between SANRAL and local stakeholders (including the Office of the Mayor of Thabazimbi Local Municipality

and Waterberg Tourism), the three parties resolved that this special tree may be retained, due to its status as an iconic landmark in the Thabazimbi area. Although the tree should be removed according to national road safety standards, and in spite of not being listed as a protected tree, SANRAL has resolved that the tree can remain if motorists are protected by the installation of guardrails.

This is being done to ensure that where possible, the conservation of natural landmarks are preserved.

The existing rest area on the south-bound carriageway (SBC) under one of the leadwood trees will also be upgraded to SANRAL standards and will be a welcome addition to the roadway.

The Iconic Monkey Thorn tree on the R510 near Thabazimbi is part of our landscape – and is here to stay amid road improvements.

PROPERTY POWER STRUGGLE CONTINUES

Dwaalboom – The plot thickens in and out of court, involving four properties totalling 5,500 hectares outside Dwaalboom. In the latest judgement between four private companies (applicants) and the respondent Bakgatla-Ba-Kgafela Communal Property Association (BBKCPA), the judge ruled in favour of the applicants, 'Interdicting and restraining the Respondent and any other person acting under the authority of the Respondent from executing any allotment and/or lease agreements and disposing of and dealing with the properties.'

In an interview with a local community member, who wishes to stay anonymous: "It's a power and property struggle involving the Bakgatla-Ba-Kgafela. A leadership shift in 2020 involved the provincial government and the High Court. Ever since then the power struggle has not ended and both sides have their own supporters. I would not be surprised if the torching of Kgosi Linchwe's property, on 23 October 2021, had something to do with this."

The power struggle is one thing... but the farmers on the property, who have invested thousands of hours and a lot of money into the farmlands in this dispute, are stuck in the middle.

A letter to the editor sent by Farmer X, reads: "This is not my fight, but it's my money and hours spent to rehabilitate a piece of farmland for which I have a valid contract supplied by the BBKCPA. We have won two court cases thus far. All I want to do is farm."

His challenge started when a community member, with no contract with the BBKCPA, started to plant sunflowers on the property in December 2021. The good rains at the beginning of the year soon transformed the fields into a sunflower haven and it is almost ready to harvest.

The community member is part of the businesses who won the latest court interdict.

The Limpopo High Court on 18 January 2022 ruled in favour of BBKCPA to 'immediately restore the property to BBKCPA for the peaceful and undisturbed possession, use and enjoy of the crops and farming purposes' of the said farms. The ruling also stated that members not affiliated by BBKCPA should immediately cease any and all farming activities.

In the meantime, the Limpopo High Court on 13 April 2022, ruled in favour of the private companies. The court stated that the BBKCPA does not have the authority to manage the properties.



Certain disgruntled Bakgatla-Ba-Kgafela community members accompanied by members of the Limpopo Economic Freedom Fighters (EFF) marched to the Dwaalboom Police Station on Tuesday 12 April.

SWARTKLIP

Swartklip – A man on his way to work, was shot in the early morning hours of Wednesday 6 April at around 4:30am. The Northam police are investigating a case of murder.

“He left his house and was about to get into his car when the trigger was pulled,” said sergeant Fortune Madisa. It was too dark for the victim’s wife to see anything. He was rushed to hospital but was declared dead on arrival.

Three suspects were arrested on suspicion of murder on the following day, 7 April. Siyabulela Koko (37), Sibusiso Matongomane (35) and Maxolo Mtunu (29) made their first appearance on 8 April 2022 and were remanded in police custody. They will re-appear before the Northam Magistrates’ Court on 25 April. We extend our sincerest condolences to his wife, family and friends.



Imbayarwo found guilty of
brutal rape and murder of
Christine Robinson

Thabazimbi – Christine Robinson (59), a retired British teacher, was brutally attacked, raped and murdered on 30 July 2014 at her lodge in Thabazimbi. Christine was a British national. She ran the Rra-Ditau lodge on her own following the death of her husband. The Thabazimbi community took a stand against farm murders when the man suspected of killing her appeared before the Thabazimbi Magistrates’ Court on 13 August 2020. She was stabbed several times before the murderer cut her throat. Police reports said she was raped and stabbed to death in her bedroom. Investigations reflect that she fought tooth and nail for her life. Andrea Imbayarwo, Christine’s 30-year-old gardener at the time, was finally arrested on 31 July 2020 on the sixth anniversary of the brutal murder. During the court appearance, the Thabazimbi community drove around the courthouse displaying signs and hooting. Christine’s niece tracked down the suspect in a honeytrap operation. Andrew Imbayarwo, who then went by the name of Andrea Ndlovu, appeared before the Polokwane High Court on Monday 11 April 2022. He pleaded not guilty to rape and murder before the case was adjourned until the trial on Wednesday 13 April 2022. But prosecutor George Sekhukhune said Imbayarwo’s semen was found in Robinson’s rooms, placing him at the scene of the crime. Imbayarwo who is from Zimbabwe, fled to his home country after the attack but returned to SA several times under false names. Imbayarwo was found guilty on charges of rape and murder on Tuesday 19 April 2022 before the Limpopo High Court in Polokwane. The case continues on Thursday for pre-sentencing procedures.

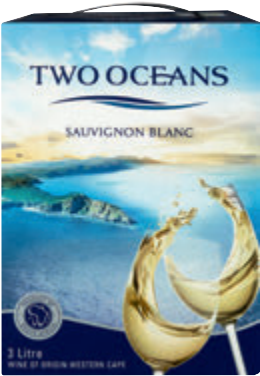

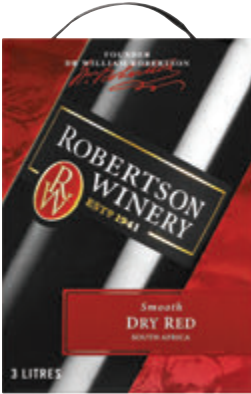
