Thabazimbi – Be extremely careful before responding to adverts on WhatsApp or Facebook. Make sure it is from a trusted source. Scammers use the 'disappearing messages' feature on WhatsApp or delete their adverts posted on Facebook as soon as they reached their targeted replies... and before those who were scammed have the opportunity to respond.

Unfortunately, thousands of cellphone SIM cards registered fraudulently in terms of Rica are on street corners, spaza shops and phone shops across the country.

One of our readers, who is a well-known community member of Thabazimbi, were recently contacted by two persons who almost fell victim to a rental scam. This is the third time *Platinum Bushvelder* reports about rental scams in Thabazimbi; only this time the perpetrator was not successful. If he did not choose the house of such a well-known community member, things might have turned out differently.

She received these phone calls...

"... I just want to know if I should pay over the deposit for the house that you are currently living in? I just want to make sure for security reasons..."

"...That house that you were staying in – is it your brother-in-law's house? I want a bit more detail as I'm looking to rent it. The man I spoke to said that you are moving out. He said that once I pay over the deposit, your husband will give me the keys..."

Finding a house to rent in Thabazimbi is a challenge. Not only are they scarce, but the rent is also usually quite expensive. So, when people looking to rent a house find one within their budget, they jump at the opportunity to rent it. Scammers are opportunists and take demand and supply into consideration when deciding and planning their scam of the week.

In a recent incident on Thursday 12 May, one of our readers received a call

from a woman asking about the deposit to rent the house she was staying in. She told her that the house is not available as she is not planning to move out. As luck would have it, the caller knows her and recognised her house from the picture, so she decided to reach out directly.

Shortly after, our reader was contacted again. This time, also by someone she knows and who recognised her house from a picture. He told her that her 'brother-in-law' said that the house was available.

In an interview with *Platinum Bushvelder*, this caller told us that he saw the house being advertised on social media.

The advertiser told him that there are a lot of people interested in the house and that if he doesn't pay over the deposit, he won't be able to keep the house for him. The man didn't want to pay over any money without seeing the house first, but the scammer

insisted that he was, at the time, with his attorney to set up a rental contract and that they could complete the contract

as soon as he receives the proof of payment. This caller found it rather suspicious, so he did a Google Maps search of the address and realised that he knew the woman staying in the house. He also reached out to her directly.

Please be careful. Before you pay over your hard-earned money, make sure you have confirmed the identity of the person you speak to. Don't let them try and rush you into taking decisions. Confirm every detail of the transaction.

SCAM OF THE WEEK

Specialised Security Services Mike Bolhuis recently sent out a newsletter regarding online knocks and scams. The perpetrators will stop at nothing to scam their victims. They often fraudulently use identities which they got of the web to conclude their fake transactions. They also have access to a range of cellphone numbers and change them as soon as their victims start asking questions.

Dit na die Universiteit van Suid-Dakota weer 'n versoek gerig het om 'n groep studente uit die VSA na Suid-Afrika te stuur vir 'n breër agtergrond oor boerdery in SA. Hulle het onder meer geleer van SA se:

- Inheemse beesras kuddes
- Besproeiing
- Wildboerdery
- Jagbedryf
- Hoe beeste, skape en wild aangepas het in warmer klimaatstoestande

Die Bosveld was prentjiemooi na die goeie reënjaar. Ergon Boerdery, die gashere, het dan ook baie moeite gedoen om die groep tot op die hoogste bergkoppe te neem vir 'n kykie na die Krokodilrivier Vallei, die springbok vlakke en die Waterberg reeks

SMITH'S ATTACKERS COURT CASE POSTPONED TO 1 JUNE

Rooibokkraal – Ten suspects who stand accused of attacking Elmarie Smith with an axe and a panga on Thursday 13 January 2022 will appear before the courts again on 1 June 2022. They were supposed to appear before court on 18 May, but the case was postponed.

The suspects, Leonard Nyathi, Behiso Nyathi, Nkiwane Zibagiso, Musagwawu Ndlena, Leroy Ndebele, Thandzawe Sithole, Nhlahla Ngwenya, Sibanda Nkanyise, Muhuhua Wetti and Vises Khumalo are facing charges of possession of a firearm and robbery with aggravating circumstances.

Smith was seriously injured when she was attacked by the men shortly after 5pm on 13 January. Her partner, Kruger, is the owner of Kukama Lodge, which is an 85km drive [north-west] from Thabazimbi, just North of the Atherstone Nature reserve – in the Rooibokkraal area.

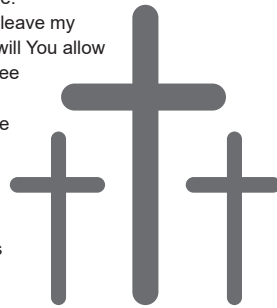

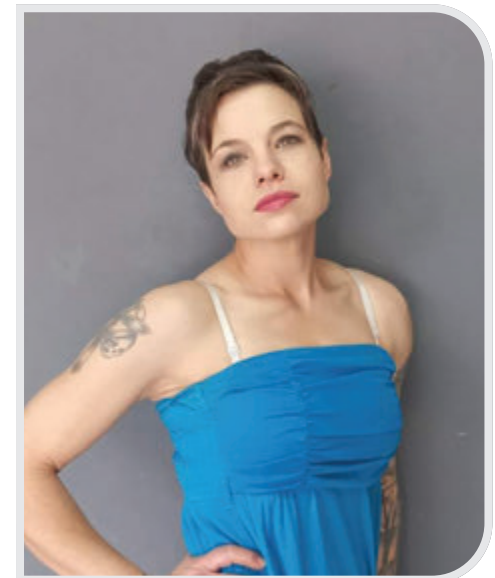

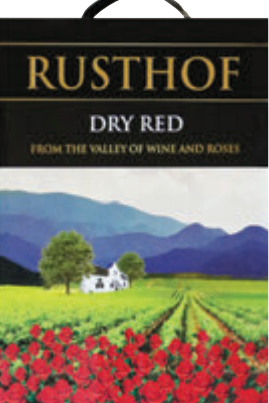
