IT'S NOT GOOGLE, IT'S THE K53

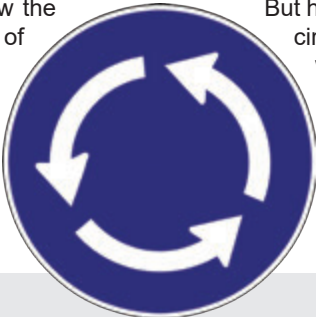
Thabazimbi – We know you all passed your K53, and some of you know the rules of the road like the back of your hand... but do you really? A lively debate recently started on social media, and then it spread to offices... and into our homes. Colleagues and family members all over are in disagreement about the road rules relating to the traffic circle located at Thabazimbi Mall.

Traffic circles, also referred to as roundabouts, is a circular intersection that is intended to calm traffic, reduce collisions, and improve intersection capacity. Those disagreeing about the rules of the circle are mostly split up into two groups, with a few following other rules we would not elaborate on now.

With some waiting for the vehicles approaching them from their right-hand side and others believing it's their turn to drive, there is a lot of frustration and hooter blowing at this circle.

Platinum Bushvelder set out to find the answer to this ongoing debate. The K53 handbook gives you all the information, rules and regulations that you need to know when it comes to becoming a law-abiding driver. So, what does it say about the rules at a traffic circle:

- *Yield to traffic coming from your right-hand side.*
- *At a mini-circle yield to traffic that reaches their yield line first before you reach yours. Drive slowly so that you*



The road sign to indicate a normal traffic circle.

In the one corner, we have team 'Right of Way'. These motorists believe that the vehicle approaching them from the right, has right of way at this circle. This means that when they get to the circle and see a vehicle approaching them from their right side, they stop and wait for the vehicle to pass – regardless if it is one vehicle or ten. They wait patiently.



The road sign to indicate a mini-circle.

In the other corner we have team 'First Come First Serve'. When these motorists approach this traffic circle at the Thabazimbi Mall, they come to a full stop. They only give right of way to vehicles which arrived at the circle before them.

A normal roundabout is marked with round blue sign with three circular arrows. Yield signs will also indicate that you have to slow down for oncoming traffic from the right.

A mini-circle is a red and white triangle sign with three circular arrows.

The red and white control signs at the mall's circle indicates that it is a mini-circle.

Platinum Bushvelder spoke to Thabazimbi Traffic Department manager Isaac Pheto. "The one to reach the Thabazimbi Mall's circle first is the one to go, only if it

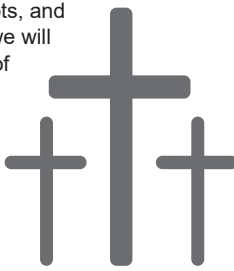

[LETTER TO THE EDITOR]



This is our back yard. We are pleading with two hands; please help!

My name is George Magoai and I live in Regorogile Extension 6 (Thabazimbi). I have to wake up every morning to the horrible smell of sewage. I struggle to sleep, which means that I also wake up tired.

We are 12 people in my home. This includes me, my wife, my wife's elderly mother, my wife's sister and her husband, my sister and six children. Two of these children are my own. I have a 7-year-old and a 1-year-old that often get sick. I even had to take my 1-year-old to the clinic and my 7-year-old to the hospital. Some of the other children also get sick and I have seen children play in the sewage. It runs down the street and has already created a stink dam of sewage.

We live in a RDP house, which also has a zinc house on the property. We have been struggling with this issue since February. I contacted management at the Thabazimbi Local Municipality and also the people employed to fix the sewage and drains for the municipality. I have been reporting it since February – on numerous occasions.

Until now, this problem has not been sorted. Every time I phone to report the issue, I am asked for my address, which I give...over and over again. And then ... nothing...

It's easy for you to go to your nice smelling home, where you can eat without the smell of sewage, and where you can get into bed and breathe clean air, not thinking about other people that have to live like pigs.

I can no longer stand the smell; this is making us all sick and we do not know what to do about it anymore.

PROTESTERS DEMAND EMPLOYMENT OPPORTUNITIES



TLM speaker Ben Tlhabadira received the memorandum.

Northam – Members of the African National Congress (ANC) staged a peaceful march in Northam on Thursday 12 May to push for more employment opportunities.

About 60 party members marched from the M Civil site camp to the Thabazimbi Local Municipality (TLM) satellite office in Northam. They delivered a memorandum to TLM speaker councillor Ben Tlhabadira and asked him to urgently attend to their demands.

Said ANC deputy secretary for Thabazimbi ward 5 Percy Seetile: "We would like the municipality to do more to create employment opportunities. Mining companies must also actively play a stronger role in employment creation. We have also asked the speaker to make sure ward 5 committee elections are held. The elections were supposed to be held in January but there have been many postponements, and this is not right."

Seetile also called for the formalisation of Helen Park Extension 20. He said the move would pave the way for proper provision of water and electricity services in the area.

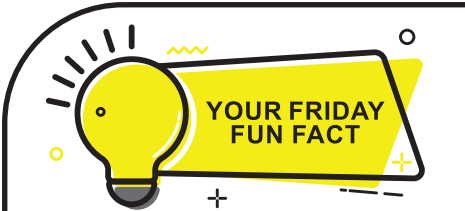

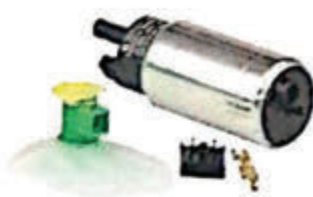
