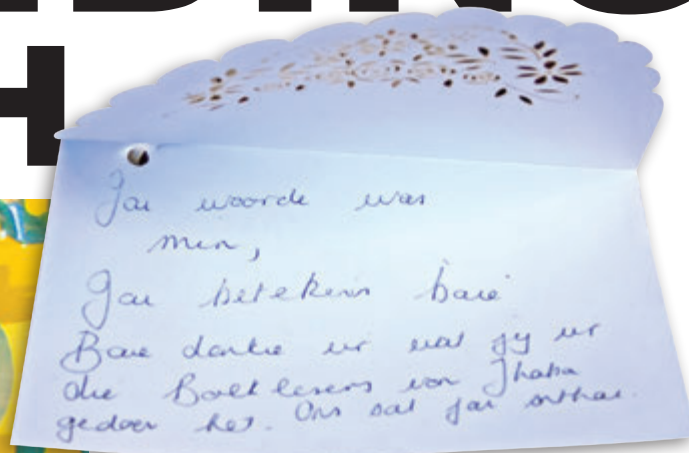

QUESTIONS SURROUNDING JUNE's DEATH



Thabazimbi – There are various speculations about the death of June Pautz, who died on Wednesday 22 June. June, who owned June's Bookshop, was a beloved and long-time resident of Thabazimbi. Her body was found with stab wounds. June's husband was brought in for questioning by Thabazimbi SAPS.

Her husband is described by friends as "a gentle person who would never harm a soul". They apparently meet up at a local lodge for a few drinks every day.

A close friend to June and her husband told *Platinum Bushvelder*: "I saw that he was upset and asked him to come and sit by us and have a drink. I asked him how June was, and he said: 'very bad' and started crying. That was Wednesday."

Apparently, June was very confused, and her condition really upset her husband, who according to several people who know him, cared a great deal about her.

The friend also said that June seldom talked to anyone and that she sometimes appeared to not be aware of her surroundings.

Community members laid flowers at the entrance of June's Bookshop.

Our sincerest condolences to the loved ones and friends of June.

Adele van der Colf, who is suffering from stage three breast cancer, is in need of more than R110,000 for hospital bills and medical tests. She is married but her husband, who takes care of their family by odd jobs, cannot afford the huge treatment costs that are essential for the proper care she requires. “In 2015, she had cervical cancer and in 2020 she got stage three breast cancer, which has spread to her lymph nodes. Adele does not have a medical aid and the family is struggling to raise the money that is required for treatment,” Charles Janse van Vuuren from Thabazimbi Cycling Club said.

“She still needs to see an oncologist to establish whether or not she needs radiation or chemotherapy. This R110,000 does not include costs for the next treatment of the stage three cancer,” he added.

“The community sponsors a cyclist per kilometre and nine cyclists will be able to participate. Cash donations are also welcome,” van Vuuren said. Members of the club also sold pancakes on 18 June 2022 at Obaro Markdag as part of the fundraising activities.
