Gareth Potgieter and Wynand Steyn, both aged 34, appeared briefly before the Northam Magistrates' Court on Monday 25 July. Venter, a 35-year-old man from Northam went missing on 11 September 2021. He took his dog and left home on foot without telling anyone where he was going.

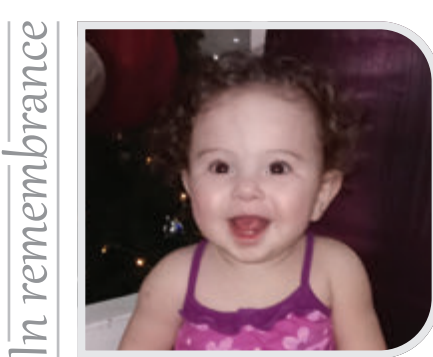

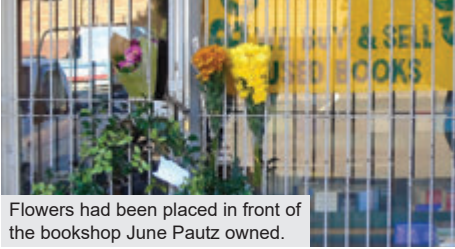
STILL NO ANSWERS REGARDING JUNE’S DEATH

Thabazimbi – June Pautz died on Wednesday 22 June and there are still various speculations about her death. Her body was found with stab wounds and her husband was brought in for questioning by Thabazimbi SAPS. June was very confused, and her condition really upset her husband, who according to several people who know him, cared a great deal about her. There are still many questions that will only be answered once her autopsy results have been revealed. *Platinum Bushvelder* reached out to the

Thabazimbi Police on several occasions, and on 14 July they confirmed that although the results are available, they refuse to give out any information. At the time of going to print, all requests have been denied, because, according to the police, the matter is still under investigation.

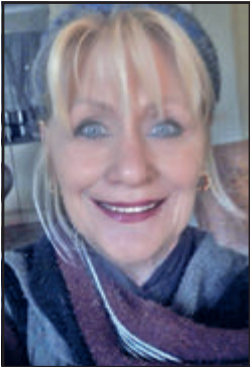

HOW MONSTROUS...

Northam – On Sunday 24 July the police confirmed the rumours about the gruesome find which has been circulating in Northam and Thabazimbi over the past few weeks. Two supposed friends of Hennie Venter, who went missing in 2021, were arrested for his gruesome murder. Gareth Potgieter and Wynand Steyn, both aged 34, appeared briefly before the Northam Magistrates' Court on Monday 25 July. Venter, a 35-year-old man from Northam went missing on 11 September 2021. He took his dog and left home on foot without telling anyone where he was going. He was reported missing at the Northam police station and the search began with family and community members handing out flyers and putting up posters. When *Platinum Bushvelder* first reported on Venter on 1 October, a family member said: "Nobody knows how heart breaking it is, we don't know whether he is dead or alive. Has he eaten? Is someone mistreating him? There are so many questions and no answers, yet we remain hopeful." Almost 10 months after he went missing, a task team comprising Crime Intelligence, Detectives, Crime Prevention, K9 Search and Rescue Unit and Local Criminal Record Centre (LCRC), with the help of forensic specialists from West Rand K9 Biology, and SAPS National Anthropology made a major breakthrough. In the beginning of July, they discovered a knife, panga and an axe on a plot outside Northam. It was believed to be the weapons that were used to commit the murder. The investigation was intensified on the plot and surrounding areas which led to the discovery of pieces of human remains believed to be that Venter. According to police spokesperson brigadier Motlafela Mojaelo, the dismembered remains were disposed of at different locations surrounding the plot. The remains were taken to the forensic

department for DNA analysis to identify Venter. The first suspect believed to be linked to the murder was arrested in Bloemfontein on 17 July and the second suspect was arrested in Northam on 23 July. Preliminary investigations indicate that the suspects were friends of Venter. He apparently visited them when they brutally murdered him. The suspects then dismembered his body and disposed of the body parts at different locations. The motive for the murder and how the victim was killed is under investigation. "During the hearing, Potgieter looked over at Venter's family and had a smirk on his face," an eyewitness at the trial told *Platinum Bushvelder*. Both abandoned their bail applications, and their case was postponed to 29 August. "I don't know what to say, I just know that they need to be punished for what they did but I don't know if I will ever be able to forgive them," Venter's father Hennie Venter senior said in an interview with *Platinum Bushvelder*.

TODDLER KILLED BY DOG

Thabazimbi – A young family is devastated by the tragic loss of their beautiful little girl who was mauled to death on Friday 22 July by a pit bull owned by their family. Jereldene King and her two girls Liane Jason (1 year, 7 months) and Miane Jason (three-year-old) live in Nylstroom while her husband Christo Jason works on a farm in Australia. They were visiting Jereldene's grandparents in Thabazimbi and arrived in Thabazimbi a week before the horrific incident. Stay-at-home mom Jereldene doted on her two girls. Her life revolves around them, and she cannot come to terms with what happened. She never leaves her children with anyone else so when her grandmother volunteered to look after the kids while she goes to a salon, she was reluctant at first. The pit bull named Rocky was just over a year old and already started showing signs of aggression. A few days before the incident, he apparently killed puppies on the same property. For safety, Rocky was kept in the back yard and the children weren't allowed to go near the dog. The grandmother was busy inside the house when she heard a commotion outside. She ran outside and saw the dog biting onto Liane. She screamed for help and did everything she could to fight the dog off. In the process, she sustained bite marks on her hands, arms, stomach and legs. One of her legs were also broken in the process and she had to be admitted to hospital. Six men ran to her aid. They jumped over the

fence and tried to fight the dog off the baby by hitting it with sticks. A call for help was sent out on the Thabazimbi Emergency WhatsApp group and within five minutes Trauma Rescue and the Thabazimbi Community Policing Forum was on scene. A vet was also called to the scene and the dog was put down. Lindy Balfour, a family member said that when she arrived at the scene, she couldn't get in to assist, as the front door was locked. All she can remember is that there were many people and that a man handed her the body of the little girl over the fence. Jereldene was still at the salon when she received the dreadful call, telling her that her baby was killed by the pit bull. "Liane was a real mommy's girl. She was very stubborn except when it came to me. The three-year-old Miane, does not yet understand what happened and is constantly asking where her little sister is," Jereldene says. She also urged parents to always be on high alert when their children are around animals, even if they don't appear to be dangerous. Christo returned to South Africa the day after the heart-wrenching incident. "We would like to thank everyone who responded to the scene. Thank you for every message and for the support we have received during this difficult time," Christo added.

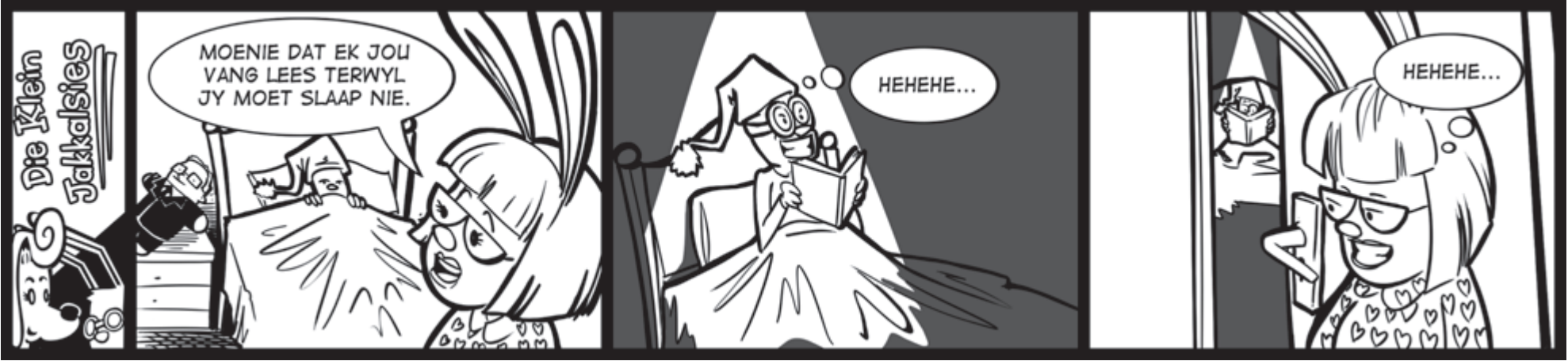


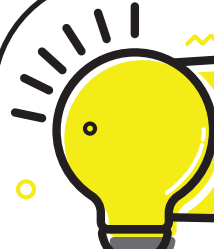

Did you know?

When you see clouds in the sky, they almost look weightless – they are floating after all! But did you know that a cloud can weigh more than 500,000 kilograms. Cumulus cloud density is given as a density of about 0.5 gram per cubic metre. A x1 cubic kilometre (km3) cloud contains 1 billion cubic metres.
