SA - On 12 August 2022 the Department of Justice and Constitutional Development issued a notice in the Government Gazette, inviting public comments on the proposed Unlawful Entry on Premises Bill, 2022 (the Bill).

The main purpose of the Bill is:

- To repeal and replace the Trespass Act, No. 6 of 1959, and
- To prohibit unlawful entry on premises.

Justice minister Ronald Lamola says the Trespass Act, No. 6 of 1959 has lost its relevance in the South African constitutional democracy. His department seeks to repeal the law and replace it with the proposed Unlawful Entry on Premises Bill, 2022 (the

- Owners or lawful occupiers may be assisted by the police to remove intruders or trespassers;
- Intruders may defend against the unlawful entry charge if there is a reasonable belief that they are entitled to legally enter the property or premises;
- · It is presumed that lawful access to the property or premises is granted if access to a door or gate is not prohibited, for example by leaving the door or gate open or unlocked:
- Intruders found guilty of unlawful entry could face a fine or imprisonment up to two years, or both.

The following amendments were made to the Act:

- Sections 1 to 3 amended by Extension of Security of Tenure Act 62 of 1997
- Section 2 amended by Criminal Law Amendment

which has lost its relevance describes in detail what a person should do when a trespasser enters his business premises.

Several terms were also changed for example: ...unless he has lawful reason to enter... was replaced bythe person charged reasonably believed that they had title to or an interest in the premises... and ...there is a presumption that access for lawful purposes...

Parliament is the national legislature (law-making body) of South Africa. As such, one of its major functions is to pass new laws, to amend existing laws, and to repeal old laws. Both houses of Parliament - the National Assembly and the National Council of Provinces (NCOP) - play a role in this process. Once it is signed by the President, it becomes an Act of Parliament and a law of the land. Has this process not become just as irrelevant as the act it now wishes to replace? Should the process not be widened in the design stages of the proposed act. So that the man on the street can understand the formation of the law and so that more roleplayers and legal experts in the field have the opportunity to contribute... rather than give a law to be commented on which is riddled with loopholes and open for personal interpretation.

You can read through the proposed bill and give

property, be it the building called home, a farm or a your inputs to the director general, or you can sit on the shoreline and watch the ship pass by. It is up to you. You must ask yourself: 'Is this law doable, or would it just work on paper?'

What are the practical implications to the detail that is given in this proposed law of how a situation with an intruder should be handled?

Let's say you opened your gate with the remote, and at the time your daughter opened the front door of the house. An intruder made use of the opportunity to gain access to your property and your house. So, following the new proposed act... the intruder might presume he/she had access because the access was not prohibited (open gate... open

Would the natural behaviour of the intruder/s be to listen as you speak to the intruder/s, informing them that they are not welcome and should leave? Would it be natural for you to then turn your back on the intruder, while they patiently wait for you to speak to the police, which might take a long time, as it is sometimes difficult to get through to the police?


Taking into account that the police struggle with limited resources, and that they might only be able to contact you back the following day, because they did not have an available vehicle or personnel..

Would the SAPS officer be responsible for deciding if there is any legal 'presumption' before removing the intruder from your house? What if the family of your ex-husband decides to rock up on your farm and removes the signage which you have placed on the gate? You phone SAPS, but because they cannot respond immediately, the family of your ex-husband, offloads their mobile home and start planting some veggies... What would SAPS do if they get to your place? Would SAPS remove them or would SAPS wait for a court order?

At the end of the day - according to the Constitution of South Africa - which is the highest law of the land, everyone has the right to protect their property and themselves.





TAXI VIOLENCE IN INDUSTRIAL AREA

Thabazimbi-Scores of taxid rivers as saulted and 20 taxis parked outside. A man employees at Ghata Instrumentation on Tuesday 23 August after accusing one of them of picking up hitchhikers. The incident occurred at the company's premises at the corner of Lood and Platina Streets.

Ephraim Mosimanegape, a supervisor at the company, told *Platinum Bushvelder* that they had to press the panic button at around 8:13 after the situation got out of hand.

"About eight taxis drove into the property

who approached us accused one of our employees of picking up hitchhikers with a white Toyota bakkie," Mosimanegape said. "One of our employees was grabbed by his neck and some of the others were also attacked," he added.

The police as well as the local community policing forum (CPF) arrived at the scene and restored order at around 8:47. The police are investigating the incident.



ALL CATTLE MOVEMENT

SA – The decision has been made to undertaken with caution. suspend all cattle movement in the country, Most new FMD outbreaks are being caused except for the movement of cattle to registered abattoirs for slaughter.

This drastic measure is expected to be very short term to halt the spread of foot and mouth disease (FMD) and catch up on vaccinations.

According to this decision, no cattle may be moved for sales, shows, lobola or any other purpose. Cattle may also not be moved into or out of feedlots except when taken directly to slaughter facilities. All exports are also halted.

The only species currently affected by the suspension is cattle. This will not affect sheep, goats, and pigs. All movements of all cloven-hooved animals should, however, be

by mechanical transmission through inanimate objects.

Snake Season – is there enough antivenom?



Thabazimbi - Following the national shortage of antivenom earlier this year, the Platinum Bushvelder asked Martjie du Preez, hospital manager of Mediclinic Thabazimbi for an update.

Du Preez says that the antivenom they have on hand is used for most snakebites, they only adjust the amount of antivenom administered to the patient, depending on the type of snakebite.

"The antivenom for the boomslang is not readily available," du Preez says. It would take the hospital between 4 to 6 hours to get it. Luckily, a boomslang snakebite is very rare in Thabazimbi, Northam and surrounds.

Wat skud

Northam - Several Northam residents reported feeling the earth shake during the late evening of Saturday 20 August. The first tremor was felt at around 23:05. One of the residents reported that her windows shook for about 30 seconds.

Several after-tremors could be felt for at least 10 minutes after the initial report.

None of the tremors were picked up by any magnitude meters, which could mean that the quake was contained to the Northam area.


