Thabazimbi – Solly Ntsimanti started his career at Bosveld Paneel Kloppers in February 2002. His main duty was to flatten the paint, but after only two weeks, panel beating piqued his interest.

He was given the opportunity to try his hand at panel beating under supervision. Throughout the years, this became not only his career but his dream to one day get his trade certificate. This dream finally became a reality at the age of almost 50 when the new owner of Bosveld Paneel Kloppers, Annetjie Fourie, decided to enrol Solly with Industry Training and Consulting. After four months of training, he officially got his trade certificate as a panel beater.

I never thought that I will be able to get my trade, but I did. I will forever be thankful to Annetjie for this opportunity. I want everyone to know that they can make their dreams come true, they should just never give up hope, even if it happens later in life."

Annetjie took over the family business at Bosveld Paneel Kloppers in June 2021 when her brother and both parents passed away. She and Solly grew up together and after her brother passed away, Solly jumped in to help her with the business.

She said that it's a privilege to have him as part of the team. "He is the type of man that will always go the extra mile and I'm extremely proud of him," she added.
