STEENEKAMP’S WORKERS ARRESTED FOR HIS MURDER

Maroelasfontein / Northam – Two farm murders within 24 hours in the Northam and Thabazimbi area on Tuesday 6 September, has put local farmers on high alert. If the last two farm murders are anything to go by, it seems that you have to stay on a farm and be a kind-hearted person, who treats others (including your workers) with respect to fit the profile of being targeted to be murdered. Steenekamp is described as a kind and generous man.

Niko Steenekamp’s two workers were arrested as suspects in his murder. Steenekamp’s stepdaughter Christine Abreu de Jesus raised the alarm on social media after his bakkie was found abandoned on the Maroelasfontein [grave] road.

Several organisations heeded the call and launched a search and rescue operation to help find Steenekamp. The Heritage Protection Group (HPG), Thaba Fire and Rescue, various CPF sectors, Thabazimbi Crisis Control Centre, Matlabas Plaaswag and Dinare Security all joined in the search. All nearby hospitals and emergency services were phoned but no one had any admissions fitting Steenekamp’s description.

On the way to the assist, Thaba Fire and Rescue received information that some items from Steenekamp’s farmhouse were missing. They immediately knew that the search and rescue operation involved a crime scene. At around 3pm, while busy talking to a farmworker, HPG announced that they found the body of Steenekamp on his farm. Investigations led to the arrests of Steenekamp’s domestic worker, his farm worker and one of his former employees. A fourth suspect was tracked down and arrested on a nearby farm. The fifth suspect in Steenekamp’s murder unfortunately got away. Some of the items stolen from Steenekamp’s farm house were retrieved.

Steenekamp will be missed by his loved ones and friends. His family describe him as a brave, spontaneous man and a loving father and husband. “His death left an emptiness in our hearts and our lives and we will forever cherish the times we had together,” Abreu de Jesus said. Steenekamp leaves behind his wife Irene Steenekamp, three children Stefan, Elma and little Simone (who is only ten years old) and three stepchildren (Christine, Chantelle and Paul).

FARMER KILLED, AND WIFE TORTURED

Dwaalboom - Martiens Richter (68) was murdered, and his wife Elsa Richter was brutally tortured on their farm in the Dwaalboom area near Thabazimbi on Tuesday 6 September.

According to posts on social media Richter went out in the dark of night to investigate after the electricity in their house kept on tripping. Reportedly that was when he was murdered.

The attackers then turned their attention to his wife. She apparently unsuspectingly opened the door as she thought it was her husband returning home. She was tortured and burned with an unknown object.

Police spokesperson brigadier Motlafela Mojapelo confirmed that the suspects ransacked the house and took two plasma television sets, firearms, cellphones, tools and other items. They loaded the items into the Richter’s Volkswagen Amarok and fled the scene.

Police received information about a vehicle in Bela-Bela that fitted the description of Richters’ vehicle. The vehicle was spotted along Potgieter Street in Bela-Bela and was pulled over. The suspects allegedly started shooting at the police who returned fire.

One of the suspects was fatally shot and another suspect was injured. The vehicle, five (05) firearms [including a toy gun], two plasma TV sets, two cellphones and tools were recovered.

Apparently both suspects were identified as farmworkers from Richters’ farm. Investigations are underway to determine if additional suspects were involved.

The Provincial Commissioner of Police in Limpopo Lieutenant General Thembi Hadebe has hailed the swift reaction of the police following a house robbery (farm attack).

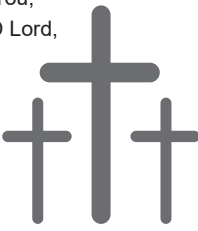

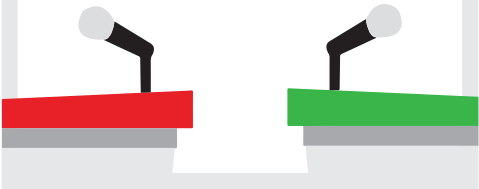

BACKGROUND: Anglo American Platinum (AAP) Mortimer Smelter is in possession of a valid AEL dated 2 October 2020. The Mortimer Smelter operation is located on the Farm Turfbult 404 KQ, Swartklip and falls within the North West province. The main objective of the Smelter is to process concentrate received from platinum concentrators, which is smelted to produce furnace matte for dispatch and further processing at the Anglo Converting Plant (ACP) situated in Rustenburg. The affected property will include portions of the following:

- Portion of Turfbult 404 KQ

The proposed variation is to make provision for the new SO2 abatement plant. The abatement plant will be utilised to capture existing SO2 emissions produced during the smelting process and convert it to sulphuric acid. This will enable Mortimer Smelter to reduce SO2 emissions in order to meet the Minimum Emission Standards as established by the Department of Forestry, Fisheries and Environment.

The original environmental authorisation for the abatement plant was issued on 12 March 2018, which was also followed by a Section 31 amendment authorisation issued on 7 March 2022. AAP will now be applying to BDM to make provision for the new SO2 abatement plant in the existing AEL.
