## Suspects in Steenekamp's murder in court

Northam Steenekamp was found murdered on suspects but later changed his story. his farm in Maroelasfontein on Tuesday 6 September.

Steenekamp's stepdaughter Christine Abreu de Jesus raised the alarm on social media after his bakkie was found abandoned on the Maroelasfontein [gravel] road. Several organisations heeded the call and launched a search and rescue operation to help find Steenekamp. It was later established that some items from Steenekamp's farmhouse were missing which indicated foul play.



# Unlawful entry on Premises Bill, 2022 ???

**Invitation for Public Comments** 



#### Take note:

- The proposed law is not applicable to government property (critical infrastructure or national key points or any public place), but it is applicable to your home, your business, and your farm.
- Of all the many unlawful acts that can be committed, this proposed law makes it the duty of law-abiding citizens (the victims) to put up signage to discourage perpetrator/s to not act unlawfully (trespass). Imagine having to put up signs for every unlawful act under the sun, to try and keep perpetrators from acting unlawful.
- This law also specifies in detail the exact steps you must follow, should a perpetrator enter your home, your business, or your farm unlawfully. Is there exact prescribes of what a law-abiding citizen should do - when encountering one of the myriad other unlawful acts of perpetrators?
- When you are a victim of a trespasser, you cannot just call on any police officer if an incident occurs. You have to make contact with an 'authorised member - means a suitably qualified and experienced member of the South African Police Service, authorised thereto by the National Commissioner of the South African Police Service to perform, in addition to their normal functions and duties, such functions as are conferred or imposed upon them by this Act.'
- If this bill is passed, and enforced... What is the consequences if you (the citizen) do not follow the rules to the T, should a trespasser enter

Justice minister Ronald Lamola says the Trespass Act, No. 6 of 1959 has lost its relevance in the South African constitutional democracy. His department seeks to repeal the law and replace it with the proposed Unlawful Entry on Premises Bill, 2022 (the Bill).

#### The following amendments were made to the Act:

- Sections 1 to 3 amended by Extension of Security of Tenure Act 62 of 1997
- Section 2 amended by Criminal Law Amendment Act 59 of 1983

The proposed 7-page bill to replace the 2-page bill which has lost its relevance describes in detail what a person should do when a trespasser enters his property, be it the building called home, a farm, or a business premises. Several terms were also changed for example:

...unless he has lawful reason to enter... was replaced by ...the person charged reasonably believed that they had title to or an interest in the premises... and ...there is a presumption that access for lawful purposes... Parliament is the national legislature (law-making body) of South Africa. As such, one of its major functions is to pass new laws, to amend existing laws, and to repeal old laws. Both houses of Parliament - the National Assembly and the National Council of Provinces (NCOP) - play a role in this process. Once it is signed by the President, it becomes an Act of Parliament and a

Has this process not become just as irrelevant as the act it now wishes to replace? Should the process not be widened in the design stages of the proposed act. So that the man on the street can understand the formation of the law and so that more role-players and legal experts in the field have the opportunity to contribute... rather than give a law to be commented on which is riddled with loopholes and open for personal interpretation.

You can read through the proposed bill and give your inputs to the director general, or you can sit on the shoreline and watch the ship pass by. It is up to you. You must ask yourself: 'Is this law doable, or would it just work

What are the practical implications to the detail that is given in this proposed law of how a situation with an intruder should be handled?

Let's say you opened your gate with the remote, and at the time your daughter opened the front door of the house, an intruder made use of the opportunity to gain access to your property and your house. So, following the new proposed act... the intruder might presume he/ she had access because the access was not prohibited (open gate... open door).

Would the natural behaviour of the intruder/s be to listen as you speak to the intruder/s, informing them that they are not welcome and should leave? Would it be natural for you to then turn your back on the intruder, while they patiently wait for you to speak to the police, which might take a long time, as it is sometimes difficult to get through to the police.

Taking into account that the police struggle with limited resources, and that they might only be able to contact you back the following day, because they did not have available vehicle or personnel...

Would the SAPS officer be responsible for deciding if there is any legal 'presumption' before removing the intruder from your house?

What if the family of your ex-husband decides to rock up on your farm and removes the signage which you have placed on the gate. You phone SAPS, but because they cannot respond immediately, the family of your ex-husband, offloads their mobile home and start planting some veggies... What would SAPS do if they get to your place? Would SAPS remove them or would SAPS wait for a court order?

# 10 STEPS TO FOLLOW IN CASE OF A VEHICLE ACCIDENT

**SA** – A vehicle accident can be a very traumatic experience. Whether it's merely a fender bender or a serious accident in which people get injured, knowing what to do, is 7. According to Section 61(1) (a-e) of the critical.

The first thing you need to remember, is to stay calm. You will probably be in shock... So, take a moment to breath and get your thoughts together. Be vigilant and make sure that it is safe to get out of your vehicle. Check for any oncoming traffic and be aware of your surroundings as criminals sometimes deliberately cause accidents, forcing you to stop so that they can rob you.

If it's safe to get out of your vehicle, you are conscious and your injuries allow you to move around, you can follow these steps:

- 1. Check if anyone else at the scene has been injured.
- 2. If there are injuries (yourself or others), contact emergency services immediately. Make sure this number is saved on your phone or where you can easily find it.
- 3. Document the accident by noting exactly what happened before the accident and after the accident while it is still fresh in 10. your memory. Leaving a voice note and taking photos can help with this.
- 4. Take photos of the vehicles before they are moved.
- 5. Get the details of the other driver(s)
- a.) Full name and surname
- b.) Contact details
- c.) Make and model of the vehicle (photo!)
- d.) Vehicle registration number (photo!)
- e.) Physical address
- f.) ID number

- 6. If there are any witnesses, get their details also. Do not leave the scene before you have taken all these steps.
- National Road Traffic Act, 1996 (Act No. 93 of 1996), it is the responsibility and duty of every driver to report an accident in which a person or animal was killed or injured immediately, or at least within 24 hours after the occurrence, and not to remove any vehicle until such removal is authorised by a police official.
- 8. Should your vehicle be unable to drive, phone a family member to come and collect you, and a tow truck company to collect your vehicle.
  - 9. That means, after you have summoned emergency personnel (if needed) and made sure to exchange details, you should phone the cops to come to the accident scene (or if it's a small accident or the cops cannot be reached, or they cannot attend the scene, open a case at your nearest police station within 24 hours). Remember to get the case number!
- Once you have a case number, call your insurance company and let them know you have been in an accident, and then some paperwork!

If you are seriously injured or unconscious, make sure you have a document in your car containing your personal and medical information. If emergency services have access to this information, it can save vital time when it comes to saving your life.
