CAT FLU IS DOING THE ROUNDS

Protect your 4-legged children

Thabazimbi – Several cases of *Parvovirus Enteritis*, better known as Cat Flu or *Katgriep*, have been identified in the Thabazimbi area over the past few weeks. Eco Vet's Jamiela Barnard says that it is crucial to immediately take your dog to your local veterinarian, if it shows the signs of being infected.

"Left untreated is as good as a death sentence for your dog. The sooner you can get your dog to the veterinarian, the better its chances of survival," says doctor Barnard.

Dogs of all ages can contract the virus but dogs two years and younger are much more susceptible to the virus. Puppies (eight months and younger) that have never been vaccinated, is unlikely to survive the virus.

Several people have lost their beloved dogs to this extremely contagious virus over the past few weeks.

Platinum Bushvelder spoke to Eco Vet's doctor Jamiela Barnard to find out more about *Parvovirus Enteritis*, how it spreads, the signs you can look out for, and the best treatment to save your dog. Cat flu affects the intestinal tract of your dog. It causes vomiting, diarrhoea, and as the virus spreads, it decreases your dog's ability to fight infection.

Oral intake of any virus-infected material transmits the infection to susceptible dogs. The virus is very contagious and commonly found in the soil and the bedding of an infected dog. It is impossible to eliminate the virus from contaminated soil without killing the vegetation. The virus can remain for up to seven months in the infected areas. It is also possible for the virus to spread over several kilometres via wind. For inside cleaning, thorough

washing and rinsing with special cleaning products is required. Contrary to common beliefs, cats cannot spread the disease to dogs.

Barnard urges owners to take their puppies to the vet the moment it starts showing signs. The vet will do a thorough examination and if they suspect that it might be *Parvo Enteritis*, they will do a snap test to see if the virus is in the dog's excretion sample.

The best treatment for *Parvo Enteritis* includes antibiotics, intravenous nutrition, medication to control pain and fever, and further supportive care, as dehydration and secondary infections can be fatal. Your puppy can also look better today and die tomorrow so it is very important to obtain and maintain the right treatment.

"Prevention is always better than cure and all dogs should be vaccinated. The first vaccination can be given at six weeks after which the dog receives successive vaccinations at nine and 12 weeks to make sure its immune system is strong. After that, the vaccinations are repeated annually," doctor Barnard advised.

If the next vaccination appointment is missed, the process is started from scratch. Vaccinations must be given annually even if the dogs are more than two years old, as it not only prevents *Parvo Enteritis*, but also provides resistance to liver viruses and other diseases such as distemper.

During the period when the dog has not yet received all the vaccinations, precautions must be taken.

Young puppies should not come into contact with other puppies that have not been vaccinated. Always keep the bedding clean and pick up all excrement. Wash all bedding, clothes, and floors that a sick puppy has come into contact with, with diluted bleach or F10 products. Protect your four-legged kids, as it is always their priority to protect you.

HOUSE ROBBED WHILE HUSBAND VISITS WIFE IN HOSPITAL



Thabazimbi – Gerrie Visagie, a Thabazimbi resident, suffered a huge loss when his house was ransacked on Friday 30 September 2022. Visagie’s wife is struggling with her health and has been in hospital for a while. He left his home at 08:00 to pay her a visit. At around 11:45, he wanted to make a quick stop at home to check if his electricity was still on. However, when he arrived, he saw marks on his front door, and he struggled to unlock it. Once he finally managed to gain access

to the house, he found that his home was raided. The cupboards were open and the contents (that weren’t stolen) were strewn on the ground. His wife’s jewellery, diamond earrings, his golden wedding ring, cellphones and cameras were stolen. The Visagie couple resides in Van der Bijl Street. It’s a busy street, or more than most in town. Anglo American Platinum Rustenburg Platinum Mines (Pty) Ltd (RPM) – Amandelbult Complex (AMB) has been operating since the 1970s and is situated in the Thabazimbi Magisterial District, within the Thabazimbi Local Municipality and Waterberg District Municipality and extends over some 20 km from west to east. The mine is a wholly owned subsidiary of Anglo American Platinum Limited (AAP) and is approximately 15 km north northeast of Northam and 30 km south west of Thabazimbi on the northern limb of the Platinum Belt.

The proposed project will involve the following supporting infrastructure and activities:

Project Name	Description
Concentrator	The upgrading of the concentrator will increase the processing capacity of the existing concentrator to treat future mine arisings.
Asbestos/potable water pipeline	Tumela and Dishaba: The replacing of the existing asbestos cement (AC) potable water pipelines supplying Tumela and Dishaba Mines will improve reliability of supply and reduce water losses as this will reduce the amount of repair and maintenance required.
Return water pipeline replacement	Replacing of the existing Holding Dam Return Water Pipeline will save water by addressing leaks and possible pollution from the leaks and also prevent possible and future contamination of the environment.
Dishaba ventilation shafts	The construction of 2 ventilation shafts at Dishaba are proposed. This will provide a flow of air of sufficient volume for the progressing of underground workings and to regulate the temperatures.
Dishaba Pipeline Upgrade at Dishaba Shafts	Replacement/ upgrading of the Dishaba process water pipelines at Dishaba 44 and 50 Decline Shafts.
Potable Water Reservoirs	Development of a potable water reservoir system and pipelines
Core Yard extension	Clearance of an area for the storage of drill cores created as part of continuous exploration activities
Decommissioning Projects	Decommissioning of Tumela 16W overland conveyor structure; Tumela 28W RB headgear, winder-house and conveyor structure; and Tumela 1Shaft overland conveyor structure
Golf course extension	Development of a driving range with a second tee box also proposed for construction.

The AMB operates under several existing approved Environmental Management Programme Reports (EMPRs), Environmental Authorisations, Water Use Licences (WULs) and Waste Management Licences (WMLs).

Before the AMB may commence with development of any of these projects, certain environmental authorisations need to be undertaken in terms of the National Environmental Management Act (Act No. 107 of 1998) (NEMA) Environmental Impact Assessment (EIA) Regulations of 2014, as amended and the National Heritage Resources Act (Act No. 25 of 1999).

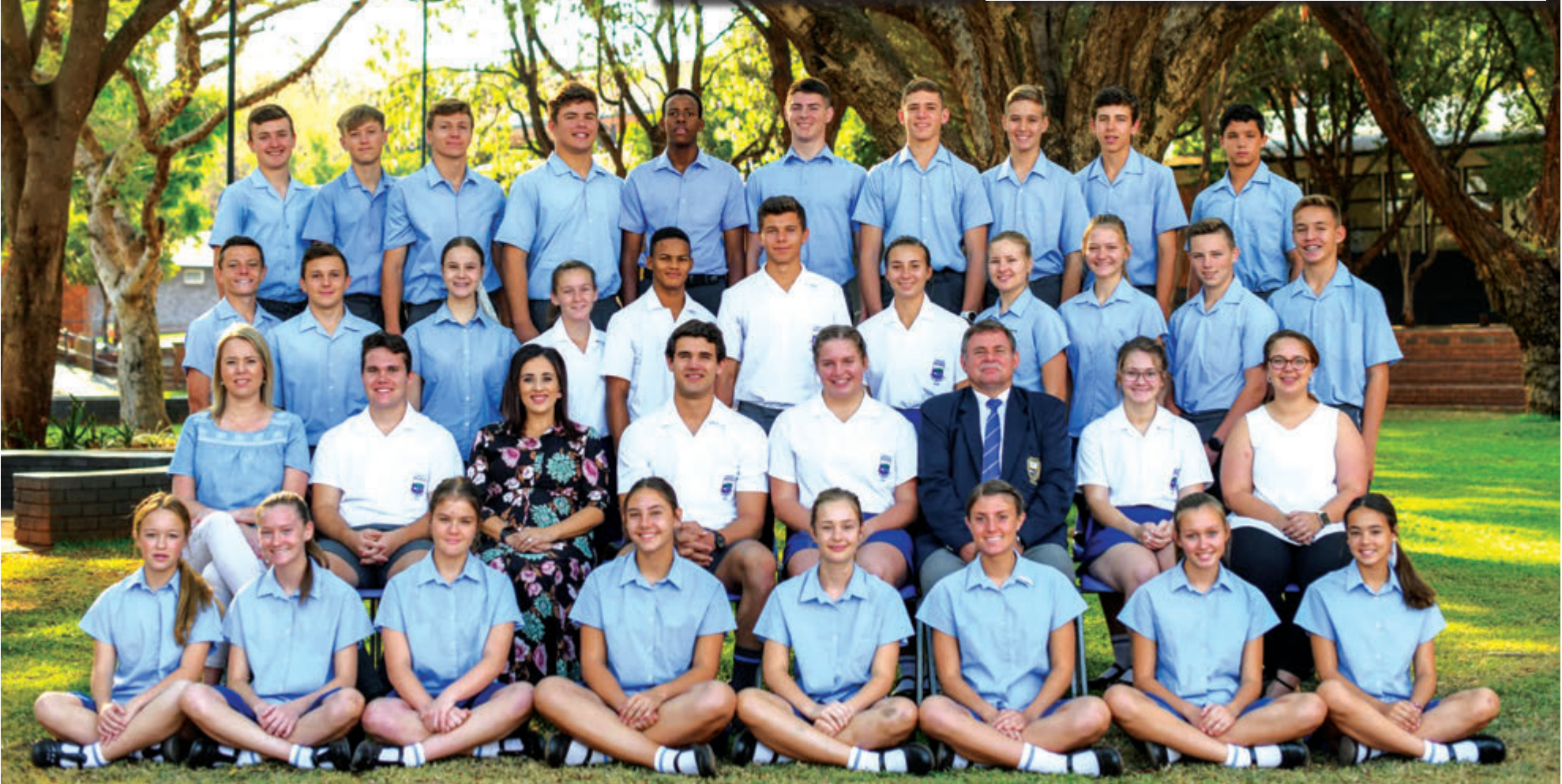

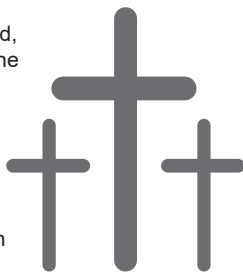
