Thabazimbi - Thabazimbi Fire and Rescue (TFR) and the Community Policing Forum (CPF) are at the heart of community safety in Thabazimbi. To raise funds to help their safety initiatives, TFR and CPF hosted a fundraising at the Thabazimbi showgrounds on Saturday 5 November.

TFR and CPF members are volunteers who give their time freely to make sure that the community has someone they can rely on in times of trouble. TFR members are a fire and emergency response team, whereas CPF members patrol the streets to keep a watchful eye over local neighbourhoods. They report suspicious activity and their presence deters crime. Unfortunately, being volunteers means they don't get paid for their contributions and they must often fork out money from their own pockets for fuel.

These members must have the resources and tools they need to ensure that they can respond at a moment's notice, whether it's an accident, threatening fire, or a lurking criminal. **See page 2...**

The potjiekos competition was a great hit with a variety of delicious potjies to choose from, but in the end, S&Z Panel Beaters walked away with the title for the best pot. Numerous stalls sold everything from ice

cream to farming implements while the kids were entertained with a jumping castle.

To give the public a better understanding of what they do, TFR and CPF asked various emergency and safety organisations to help them with the demonstrations.

Assisted by Trauma Rescue and Amandelbult Fire and Rescue, one of the TFR demonstrations showed how an injured person is usually rescued from the wreck of a vehicle. In another demonstration, CPF members showed how they assist the Thabazimbi police in catching a suspect in a speeding vehicle.

The South African Police Services' water wing unit also gave some insight into their operations and the equipment they use when doing search and rescue operations in water.

Approximately 2,000 people attended the event and the two organisations managed to raise an estimated R30,000, which will go a long way towards helping ensure community safety.

Pierre Loods, director of TFR would like to thank the community for their support and would like to remind the public that TFR and CPF's expenses are ongoing. "Every time a volunteer gets into their car to assist with a fire, accident, or an incident of theft, that volunteer has to pay for his or her fuel," Loods said.

No swimming in the Crocodile River

Thabazimbi - Over the last few days, Thabazimbi and surrounding areas have been blessed with an abundance of rain. Unfortunately, rain also brings new risks.

Thaba Fire and Rescue measured the water level of the Crocodile River and it's still 5.8 metres away from reaching the bridge. The waters from Hartebeespoort Dam have reached the river, but at this stage, there

is no cause for concern that the bridge will flood.

However, Thaba Fire and Rescue would like to warn the community to stay clear of the Crocodile River - even by boat - as the current is very strong. They also request the community to avoid swimming in the river as strong currents often bring crocodiles and hippopotamuses to the area.

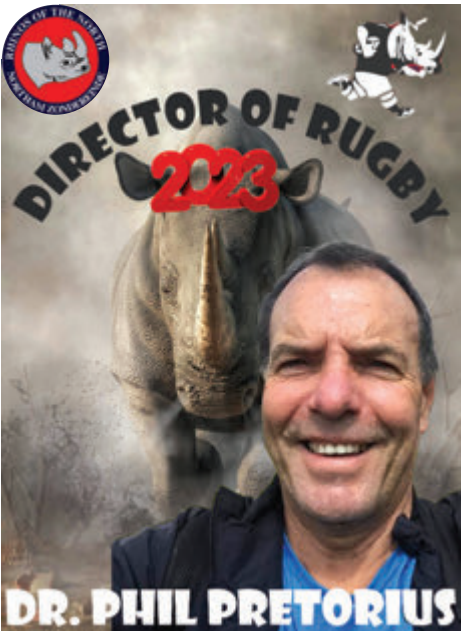




Northam Rhinos warm op
