CAPTAIN MODISE SET FOR RETIREMENT

Thabazimbi – After 35 years on duty, including six years as South African Police Service (SAPS) acting station commander (at both Hoopdal and Thabazimbi), captain Ananias Modise (60) is set to retire on Thursday 28 February 2023. Captain Modise started his career at SAPS in 1987 at the age of twenty-four. Captain Modise was the first in his family to join the South African Police Services and made captain in 2015 in Hoopdal. He later became the SAPS acting station commander in Thabazimbi in 2021.

During his time at Hoopdal (2015-2018) where captain Modise became the station commander in 2017, his station was nominated for the best performing police station in the Limpopo province. To this day, captain Modise still has the envelope in which he received his performance bonus. He kept the envelope as a reminder that hard work and dedication makes a big difference.

Captain Modise's advice to younger officers is to stay disciplined, abide by the code of conduct, and to respect seniors. He said that officers should uphold the constitution of South Africa and put the needs of the community first. "Whatever you are doing, let God be the driver of your life's vehicle, don't let Him take the back seat," said captain Modise in an interview with *Platinum Bushvelder*.

He said that he is excited about the adventure of retirement, as he is going to take the opportunity to spend more time with his wife to whom he has been married to for thirty years. Captain Modise also plans to spend time with his family—especially his grandkids.

Captain Modise, who is also a pastor, further plans to put his extra time into helping the church and his community. "I have served my country, now I am going to work for God."

Thabazimbi – A man who stands accused of two separate charges of sexual assault made another appearance before the Thabazimbi Magistrates' Court on 22 February 2023. This came after his previous bail application on Thursday 16 February 2023 was postponed. During the latest court appearance, the matter was once again postponed until 6 March 2023.

The accused was initially arrested with two other suspects on 26 January 2023 after it came to light that a child was sexually assaulted and that two children were brutally assaulted with a cricket bat. The man was granted bail of R2,000 on 8 February 2023 on the first charge, but was remained in custody when an additional charge of sexual assault was filed against him.

He will remain in custody until his next court appearance to find out if he will be granted bail on the second charge.

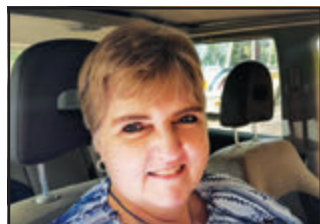

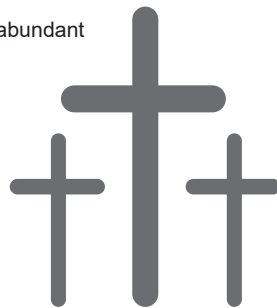

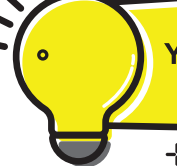

Thabazimbi – Thabazimbi is now home to two indoor archery world champions! Dr Gary Bauer and Hendrik Johannes (HJ) Swanepoel represented South Africa in Gillingham, Kent, in the United Kingdom from Monday 13 to Friday 17 February 2023.

It's an enormous honour as 500 archers from 28 countries participated in the 2023 World Indoor Archery Competition (WIAC).

Dr Gary Bauer participated in the Veteran Male Freestyle Unlimited (VMFU) category. He was tenacious in his approach. Session one saw Gary in 12th position with a 297/300 score. The flint round (distances ranging from approximately 5-30 metres) had Gary fighting back with a score of 279/280 and grabbing the gold medal with a 300/300 score in his last session.

HJ Swanepoel held on to the first place in his category of Adult Male Freestyle Unlimited (AMFU) from day one. He never let go of his concentration. This gave him a 300/300 score on day one. HJ Swanepoel had to really focus for the flint round as eight men were in the lead. However, he grabbed first spot with a 279/280 score, and he clinched the gold medal with 300/300 score on day three. Both also took gold in the team competition.
