

Thabazimbi – Some families are able to name their favourite snake. For the Van Breda family, this is not unusual as every member of their family has a favourite snake to mention. In an interview with Platinum Bushvelder, snake enthusiast Jaco van Breda (12) shared some useful information regarding snakes

Jaco van Breda knows quite a bit about snakes. According to his mother, Windi van Breda, Jaco was barely a year old when he held his first snake. Jaco was taught about snake safety from a very young age, and his favourite snake is a python. He is able to identify different snakes and can clearly differentiate between venomous and nonin the veld, it's always wise to use a long stick to clear the grass ahead of you. Most snakes are the chances of the snake biting you decrease. After biting the stick, the snake could also give you a dry bite as it has already used its batch of

tips on identifying a snake that displays threatened behaviour. "Most snakes roll up and pull their heads back. The cobra increases the size of its head, and a puff adder hisses at you," he explained.

Jaco also knows the protocol for handling a snake bite. "You should never try to suck out the poison. This will not help the person and you will also have poison in your mouth," said Jaco. Instead. Jaco advises that if you are bitten, it's best to try and take a photo of the snake, or at least look for distinct markings on its body that will help to identify the snake. "A description of the snake will help to identify it, this helps doctors to give the venomous snakes. Jaco explained that if you are right anti-venom," added Jaco, According to Jaco. snakes play a very important role in nature. If we didn't nave snakes, rodents would take over, which naturally shy, and movement drives them away— means that they would spread their diseases and least 5 m and call for or at the very least enables the snake to give you a even damage crops. When it comes to teaching kids about snake safety Petrus, the owner of Reptile Inc.—a snake park in Thabazimbi—shared a few tips. "Kids are always curious so it's important that we teach kids to always be careful around snakes," Petrus warned. He added that parents should teach kids that if they see a snake, they should never try to catch it or kill it themselves. The best option is to make sure that kids understand to keep an adult to assist.

Road closure hinders emergency situation

Thabazimbi – The roadworks at the train bridge near the Ben Alberts turn-off almost turned deadly when a patient couldn't be transported over the bridge on Friday 10 March 2023.

A notice was sent out to residents to confirm that the road would be closed between 11:00 and 12:00.

According to Thabazimbi Fire and Rescue (TFR) Pierre Loots, a man was waiting to cross when he had either a stroke or a heart attack. Passers-by noticed that something wasn't right, but struggled to get the man out of his vehicle as it was locked.

Passers-by eventually managed to get him out, and TFR arrived at the scene, but there was no ambulance in the area available to assist. Emergency services from Thabazimbi's side were unable to access him due to the scheduled roadworks. Fortunately, Trauma Rescue managed to dispatch an ambulance from Northam and emergency responders managed to stabilise the man. Once he was stable, he had to be carried over the bridge and was loaded into Pierre's bakkie. Other members of TFR escorted them to hospital where the man was admitted. Terrific teamwork saved the day.

A breath of fresh air for Thaba

Thabazimbi – The Thabazimbi Business Chamber aims to brighten up Thabazimbi and get the community involved to bring about change by planting 'spekbome' in the Thabazimbi surrounds.

Driansu van der Nest told *Platinum Bushvelder* that the 'spekboom' initiative started at the beginning of last year and by end of February 2023 the project truly gained momentum.

All you have to do is plant spekboom cuttings and maintain it. The Business Chamber will provide the cuttings, and where needed they will assist with workers, water and equipment. The plant, also known as an ElephantBush, Dwarf Jade, or PorkBush has bright green, circular leaves, and has the ability to absorb up to 4 tons of carbon per hectare, consequently having a positive impact on climate change and air quality.

The spekboom is native to the Eastern Cape where elephants like to feast on their tasty leaves, hence the name 'ElephantBush'. Water is also not a problem for the environmentally friendly plant as it is drought resistant and can survive on 250 mm to 350 mm of water per year and is incredibly adaptable.

The cuttings should be planted 10 cm apart and needs to be watered once every two weeks—it really is that easy!




