Thabazimbi residents are with their backs against the wall because of poor service delivery

**Thabazimbi** – Poor service delivery has become a major concern for communities falling under the Thabazimbi Local Municipality (TLM) jurisdiction.

Issues such as having no water for days on end, power outages, sewerage problems, littered streets and potholes are making life in the municipal area unbearable. There is an outcry on social media. Some people are on the verge of giving up, while others are putting their heads together to explore alternative options to get basic services like water, which is needed to survive and sustain an acceptable standard of living. Fed-up community members feel their pleas are falling on deaf ears. *Platinum Bushvelder* reached out to community members on Tuesday 28 March 2023 to hear their concerns.

"I stay in Regorogile and it's a struggle. Loadshedding really complicates things because during loadshedding we don't have water. This means that we can't wash the laundry or even cook. There are people who sell water, but it can cost up to R700 for 100 litres. More often than not, we just wait it out," said Lerato Mfisa. According to Lerato, a municipal water truck comes by every now and then, but it isn't able to deliver to all of the houses.

Lerato added: "I have a child in school, I want him to come home after school to a cooked meal and have a bath but that is not always possible due to water issues. Fortunately, the people in Regorogile help each other. If people have water, they are often willing to share with those who don't, even if it's just enough to cook a meal."

A Thabazimbi resident who stays in town, Frederika van Aswegen, says that 'water' has been a longstanding issue in Thabazimbi, regardless of loadshedding. "If there is water, the pressure is very low," said Frederika.

"The water truck comes by sometimes, but even then, JoJo tanks can't be filled completely because there isn't enough for everyone. Having a borehole also doesn't mean much because frequent loadshedding means that borehole pumps can't pump water—unless you have a generator, which becomes another expense. However, when there is power and the borehole pumps are working, people help each other with water."

Community members feel that the political power play surrounding the TLM has added to their woes. "Government officials and municipal workers are paid by the taxes of the community. They should serve the communities no matter what their political affiliation is," *Platinum Bushvelder* was told by an anonymous resident.

Although community members support each other in these difficult times, they are running out of options and running out of patience.




