Thabazimbi – It's no secret that many areas in Regorogile and other parts of Thabazimbi go for long periods of time without water. Consequently, children living in Regorogile don't always have access to basics such as drinking water, bathing water, and clean clothes—let alone a cooked meal! Volunteers and members from Thabazimbi Feed the Poor identified Regorogile's critical need for water, and with the Word of Jesus, delivered 800 x 50-litre barrels of water to the most affected areas in Regorogile on Tuesday 25 April and Wednesday 26 April 2023.

Thabazimbi Feed the Poor is a non-profit organisation (NPO) that strives to provide love and care to underprivileged children and families. Daily, Thabazimbi Feed the Poor takes care of more than 100 children's basic needs while adding Biblical principles to their daily lives. Despite the great task at hand, the NPO also tries to encourage, motivate, and uplift the children who rarely have a special occasion to smile for.

After receiving financial donations from various anonymous donors, the NPO decided to put the will of Jesus into action in January 2023 with its 'Living Water' project, where to date, 800 x 50-litre barrels have been purchased and filled with water. Two locals, who prefer to remain anonymous, spent time after work and used their own resources to paint the Name above all names, 'Jesus', on the barrels. Thabazimbi Feed the Poor would like to make it known that this amazing feat was not made possible by man but by the will of Jesus and His Father the Almighty. "For I will pour water on the thirsty land, and streams on the dry ground; I

will pour out my Spirit on your offspring, and my blessing on your descendants," says Isaiah 44:3. Volunteers and members from the NPO who delivered the barrels to households in Regorogile also relayed the message of Jesus' love to each recipient. "Jesus loves them and cares for them and desires for them and their loved ones to become part of His Kingdom and start living their lives as conquerors, even in their devastated circumstances which very few of us will be able to overcome or tolerate," said a member of the NPO. "I'm relieved, the prayers and the water have made a difference," said Regorogile community member Robert Khwareli.

Thabazimbi Feed the Poor aims to identify other areas in need and would like to collect an additional 2000 barrels for its 'Living Water' project. The NPO thanks everyone who gave a helping hand and would like to invite anyone willing to spread Jesus' love and goodwill to partake in their project. BURNT REMAINS
FOUND IN REGOROGILE

Thabazimbi – Information has been circulating regarding the remains of a burnt body that was discovered in Regorogile extension 3 on Friday 21 April 2023.

The information indicates that the remains are that of a child who was burnt after his/her death. However, according to information received from warrant officer Jaco Havenga, A young man from the Regorogile community was busy collecting firewood on a nearby mountain when he discovered the remains. Police responded to the scene, and it is alleged that the remains were burnt because of a veld fire that occurred approximately three weeks prior to the discovery.

At this point, specific details surrounding the identity of the body remain unclear. An inquest docket has been opened and the case is under investigation.

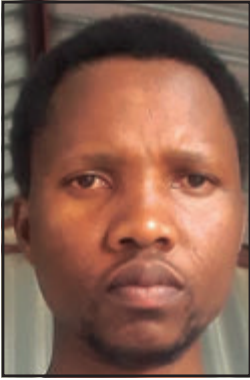

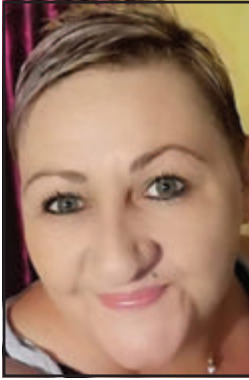
Do you keep in touch with your ex's family?
