With prices constantly increasing and job opportunities becoming scarce, individuals are left searching through their pockets just to make ends meet. CHILD ABUSE CASE POSTPONED AGAIN

Thabazimbi – The case against the three suspects who face charges of sexual assault, child neglect, and assault with the intent to inflict grievous bodily harm was once again postponed on Friday 19 April 2023. The trio will appear before the Thabazimbi Magistrates' Court again on 29 June 2023. The man was initially arrested with two women on 26 January 2023 after it came to light that a child was sexually assaulted and that two children were brutally assaulted with a cricket bat. On 8 February, the two women were granted bail of R1,000 each while the man was granted bail of R2,000 on the first charges, but he remained in custody after an additional charge of sexual assault was filed against him. He was released on 13 March 2023 on R2,000 for the first charge, and R500 for the second.

This heart-warming stew incorporates affordable kitchen essentials and is not only capable of satisfying 5-6 hungry stomachs but also remains budget friendly.

Sanet's 'Koedoe Stew' recipe

- Ingredients:**
- 1 x chopped carrot
 - 1 x chopped onion
 - 3 x tablespoons of oil
 - 250g chicken/beef (optional)
 - 500g pasta
 - 1 x chopped tomato
 - 3 x teaspoons of tomato purée (optional)
 - A pinch of garlic
 - A pinch of salt
 - 2 x cups of margarine
 - ½ cup of soup powder (hearty beef, brown onion, or any flavour of your choice depending on your meat selection)

Method:

1. In a large pot, brown the onion in the oil for approximately 7min (along with meat if desired).
2. Fill the pot with 750ml water.
3. Add chopped carrot, tomato, garlic, salt, and purée and simmer for approximately 15-20min until soft.
4. Add margarine and soup powder (mixed with water). Stir until dissolved.
5. Add 500g macaroni and boil for approximately 10min.
6. Serve and enjoy!

Anglo American Platinum Rustenburg Platinum Mines (Pty) Ltd (RPM) – Amandelbult Mine Complex (AMB) situated in the Thabazimbi Magisterial District, within the Thabazimbi Local Municipality and Waterberg District Municipality is a wholly owned subsidiary of Anglo American Platinum Limited (AAP). AMB is approximately 15 km north, north east of Northam and 30 km south west of Thabazimbi on the northern limb of the Platinum Belt.

As part of the AMB mechanisation strategy to transform from conventional to mechanised mining by 2032, AAP intends to commence with a project across its operations in the AMB mining right area, which will consist of four individual projects:

- Middellaagte Project
- Tumela 15E Extension Project
- Tumela 1 Sub Shaft Project
- Dishaba East Mechanisation Project

An overview of the above projects is provided in the table below.

Project description	The Middellaagte Project is a greenfield project and will require the implementation of new mining infrastructure to access and support underground operations. The project will primarily be supported by the existing Tumela 15E infrastructure for personnel and material. The project is brownfields and will leverage the existing mining infrastructure at Tumela 1 to support the underground operation. Additional surface mining infrastructure will be required for the proposed project such as offices and workshops.

In addition to the application of the abovementioned projects, AMB has also agreed with Cronimet (Pty) Ltd to acquire a portion of their mining right over the Farm Middellaagte KQ Portion 1 for the purposes of the Middellaagte Project. Due to this, the AMB Complex would like to include this property into the existing AMB Complex mining right, thus a Section 102 mining right amendment is required as part of this environmental authorisation process.

Before AAP can commence with the projects, the necessary authorisation and licences from the Department of Mineral Resources and Energy (DMRE) and the Department of Water and Sanitation (DWS) need to be obtained. Due to the nature and extent of the proposed activities, a full Scoping and Environmental Impact Assessment (S&EIA) process will be undertaken as part of an integrated Environmental Authorisation process, to obtain authorisation from the DMRE in respect of the National Environmental Management Act (Act No. 107 of 1998) (NEMA). Furthermore, a Section 102 application in terms of the Mineral and Petroleum Resources Development Act (Act No. 28 of 2002) (MPRDA), will be required since the Expansion Project will require the mine to amend their Mine Works Programme. In addition to this, a Section 102 of the MPRDA will be required to include the mining right for Farm Middellaagte KQ Portion 1 into the existing AMB mining right.
