Kids had the opportunity to form new friendships and develop sportsmanship.

Thabazimbi - Thabang Children's Project hosted a fun-filled sports day at the Thabang Child and Youth Centre on Thursday 15 June 2023. Neos Christian School and Koedoeskop Primary School learners, educators, and parents joined in the soccer and netball camaraderie. The day was an excellent opportunity for the kids to get together and have fun on and off the soccer and netball courts. The Thabang Children's Project makes a difference with the services of its Child and Youth Centre and its drop-in centre at Smash Block. The youth centre accommodates 32 children who need care and attention. Abused, neglected, orphaned, and abandoned children are placed in Thabang's care by the state until alternatives can be identified. Meanwhile the drop-in centre at Smash Block

helps children—who are identified with the help of the Department of Social Development—with their homework and provides them with a daily meal. Additionally, Thabang's drop-in centre also provides educators who help with the children's studies twice a month, as well as several other upliftment initiatives. Trollope Mining Services helped to make the sports day possible as they donated a multi-court—which was completed in November 2022—to the Thabang Children's Project. The kids can play soccer, tennis, netball, hockey, and cricket to their hearts' desire on the multi-court. "We are very proud of what was achieved with this project and the smiles, and sense of sportsmanship is heartwarming," said Trollope Mining Services event organiser

Cindy Pistorius. The successful sports day had Koedoeskop Primary School learners walk away as the overall netball champs, while Thabang's children took overall victory on the soccer field. "It was a blessing to see the learners, parents, and educators, come together and have a good time with our kids. Kloppers case develops



Northam – Freek Kloppers (30) tragically lost his life on the evening of Tuesday 6 June. At the time of going to print on 16 June 2023, the tragedy was suspected to be due to a hunting accident on a farm near Northam. The victim's wife, Megen Kloppers (25) was arrested for culpable homicide, and for the possession of an unlicensed firearm and ammunition. "Megen Kloppers appeared before the Northam Magistrates' Court on Thursday 8 June, where her case was remanded to 14 June," said Limpopo provincial commander of SAPS media relations colonel Malesela Ledwaba. National Prosecuting Authority (NPA) Limpopo spokesperson Mashudu Malabi Dzhanghi confirmed on 20 June 2023 that Megen Klopper's case has changed from culpable homicide to murder. "Freek will be missed," said Freek's cousin Barnard Kloppers, "I would have loved for another opportunity to hunt with him on the farm." Freek's funeral service took place on 21 June at 10:00 at the Dalunie Church in Rashoop, Brits.

Roads Agency Limpopo and Thabazimbi Local Municipality address road issues

Thabazimbi – On Wednesday 14 June 2023 TLM started with the resealing and patching of potholes project of internal streets in Northam by attending to some streets in Northam Extension 2 and Northam CBD as well as Thabazimbi Road. Motorists and residents of the Thabazimbi Local Municipality (TLM) are due for an improved driving experience as the Roads Agency Limpopo (RAL) collaborates with municipalities to implement road infrastructure service delivery. RAL draws from its vast expertise to assist the municipality with maintenance works. As part of the collaboration between RAL and TLM, streets such as Chroom, Onyx, Botha, Oppal, Tungsten, Platina, and Mangaan Streets within Northam Township will be addressed to make them pleasant to drive on. Part of the scope of work on these streets includes addressing road issues such as pothole deep patching, milling, and overlay in various streets that have seen considerable deterioration over the years. These streets fall within the municipality's town and residential areas. RAL endeavours to foster collaborative efforts amongst all the stakeholders in the province's road infrastructure delivery. Through the cooperative approach, the Agency anticipates a display of noticeable impact, which will improve the driving experience for the people of the Limpopo Province. The MoA gives effect to a deliberate district development model that calls on district mayors to be in the frontline of streamlining efforts on initiatives that seek to achieve a shared vision and execute road infrastructure development programmes.

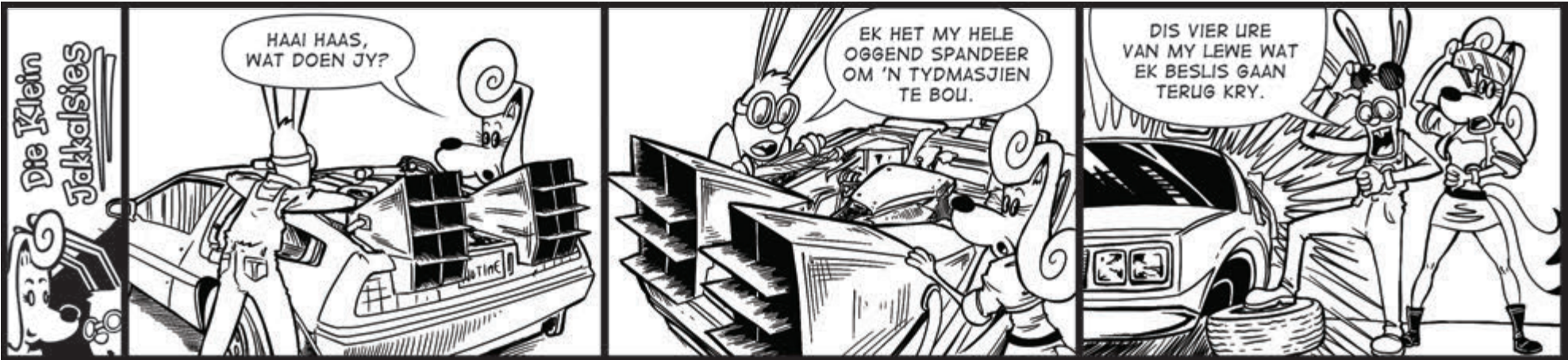
