Thabazimbi - As a woman, I've experienced an interesting phenomenon when it comes to car guards. Whenever I drive with my husband or brother, I notice that the car guards don't help them to reverse out of a parking bay. On Saturday 8 July 2023 I went to do some necessary grocery shopping on my own. I parked my car, and there was no car guard in sight. I finished my shopping, and as I was about to leave, the guard miraculously appeared behind my vehicle and decided for himself that I needed assistance with reversing. I should mention that has happened to myself and some of my friends many times. So, because I am a woman, does it automatically mean that I don't know how to reverse, or what is the reasoning? I should also mention that I would not be driving a car if I did not pass my driver's licence-which included testing my ability to reverse.

Don't get me wrong, car guards can be very helpful, and everyone is entitled to earn a living. But at least give me the chance to ask for assistance when it comes to reversing-don't just assume. ALARM RAISED OVER SEWAGE POLLUTION

As reported in Platinum Bushvelder's 30 June issue, the Crocodile River tested positive vibrio cholera. The Thabazimbi Local Municipality responded on the issue saying: "None of our water sources are connected to the river. The municipal water is free from cholera. We appeal to community members staying close to the Crocodile River to refrain from drinking and using the water from the river".

In the meantime, social media has been abuzz about the cause of the contamination. According to a press release issued by the Freedom Front Plus Limpopo chairperson Marcelle Maritz on Thursday 6 July 2023, The FF Plus has lodged another complaint with the Human Rights Commission (HRC) because of water sources which are being polluted by sewage.

Extracts from the 6 July FF Plus press release, "The communities of Rooiberg, Raputi and Leeupoort fear that their health may suffer, and that the local ecosystem may be seriously damaged seeing as untreated sewage from the Thabazimbi wastewater treatment plant is flowing into the Rooikuil tributary which, in turn, flows into the Crocodile River.

In addition to the fact that the wastewater treatment plant has never been fully functional, a power cable was stolen about five weeks ago and it still has not been replaced.

Conserving nature is of crucial importance for both humans and animals, and the municipality must fulfil its obligations towards the community by properly providing services.

The pollution of water sources must not be tolerated seeing as water is already extremely scarce in Limpopo.

The FF Plus has been raising the issue of spillage from the Thabazimbi Wastewater Treatment Works WWTW since 2019. Since then, the TLM has been under the leadership of both the Democratic Alliance and the African National Congress (ANC). Part of Platinum Bushvelder's inquiry to the FF Plus was for information on the date, organisation and results of tests confirming the contamination into the Rooikuilspruit which drains from Thabazimbi in a southerly direction where it meets up with the Crocodile River, but we have not received feedback on that.

While governing bodies should be held accountable for service delivery, it is important to note that crime and loadshedding also contribute towards the spillage of the WWTP. To prevent failure of the wastewater system, the theft of electrical cables in the area needs to be addressed and a solution for the proper functioning of the wastewater treatment system during loadshedding also needs to be put in place. Platinum Bushvelder will continue to monitor the situation and report on any updates.



It is said that sewage from the Thabazimbi Wastewater Treatment Works flows into the Rooikuilspruit which is a tributary of the Crocodile River.





"Brave is to just do it!" says Maya

The definition of 'brave' adjective : ready to face and endure danger or pain; showing courage.

Thabazimbi - October 2017 was the start of a nerve-racking journey for the Broekhuizen-family of Thabazimbi. Maya, their 11-year-old daughter showed signs of a common cold. A week later Maya's legs became weak, she fell, couldn't stand, and had difficulty breathing as a vicious viral infection started slowly draining life from this once healthy body.

Dr Janamari du Plessis in Thabazimbi diagnosed Maya with Guillain Barré syndrome (GBS), and immediately the fight for Maya's life began with an emergency ambulance ride to Unitas hospital.

"Poor judgement at the emergency department, 12 gruelling hours waiting for a paediatrician, emergency tracheostomy, and two weeks of full ventilation while sedation followed. Another two weeks of ICU, using breathing and feeding tubes, several blood tests and Polygam treatment, was no easy feat," said Maya mother, Mathilda Broekhuizen. After 32 days in ICU, Maya was moved to

Muelmed Rehabilitation Centre. "We went against doctors' and rehab specialists' recommendations and believed that prayers and a miracle will await us at home. Maya came home just before Christmas in a wheelchair. having to re-learn all movement speech," said Broekhuizen, Maya's father. "We kept believing that the Lord our

God will heal her."

Maya was home-schooled from Grades 1-6. She completed her Grade 7 year in Laerskool van Wykskraal and started Grade 8 at High School Frikkie Meyer.

However, some of Maya's Guillain Barré symptoms lingered, including hypersensitivity on her feet, waking up with hand and arm tremors, speech impairment, and some slow movements. Her smile only returned five months after her hospitalisation.

"This journey has cemented our faith and every day we see a walking miracle," says Mathilda Broekhuizen, Maya's mother.

Their advice to all parents is to keep believing that the Lord Jesus Christ still works miracles. "Trust in the Lord and your ability to hear the Holy Spirit. Strong family ties are your weapon."

But they still had a long journey ahead of them. Dr Berna Faulds, a biokineticist in Thabazimbi, helped with daily exercise routines.

The family re-evaluated their life: emotionally they were off stronger, their faith grew, and Maya taught them perseverance.

Her perseverance paid off. She resumed with the family sport: archery. It was difficult at first to keep the bow straight and gain strength to pull the bow. But she is a warrior!

At the age of 17, Maya stepped into the Adult category and has proven herself worthy.
