Thabazimbi – As from Tuesday 1 August no liquor will be sold in Limpopo after midnight. The Limpopo Department of Economic Development, Environment and Tourism (DEDET) is implementing the amendment to the Limpopo Liquor Act.

Thaba Nkwe Bushveld Inn manager Chantell Saunders behind the lodge's bar.

Limpopo DEDET member of the executive council (MEC) Rodgers Monama announced that the curfew aims to reduce gender-based violence, rape, child abuse, accidents, and other violence-related crimes in Limpopo.

However, business owners might not share the same sentiment. "The leisure and entertainment industry took a massive knock during Covid-19, and some businesses, especially those who did not receive support during the pandemic, are still trying to get back on their feet," said Thaba Nkwe Bushveld Inn owner Tony Anderson in an interview with *Platinum Bushvelder* on Wednesday 26 July. "The law is the law, and if it is implemented, we will abide. But I think fighting crime is being approached from the wrong angle; instead of negatively affecting businesses, law enforcement needs to improve its operations to reduce crime."

Platinum Bushvelder also reached out to Thabazimbi's SAPS office, who indicated that they have not yet received any official notice of the change in curfew for the selling of alcohol.

On social media, several pub owners have voiced their discontent with the new regulations, while a lot of people have expressed their hope that the curfew might bring an end to taverns making a lot of noise until the morning hours.

While discussions continue between provincial authorities and businesses affected by the new regulation, it remains to be seen whether there will be a drop in crime with the implementation of the new curfew.

BANK NOTE FRAUDSTERS APPREHENDED

Thabazimbi - Fraudsters, four women and one Lekkerbek Liquors owner Edwin Beyers in an unidentified driver, took their chances at Lekkerbek Liquors on Jacaranda Street 2 on Friday 21 July 2023. The suspects, who were driving a

red Toyota Etios, stopped at the liquor store where they proceeded to make their purchases with counterfeited R200 notes. "The women did not enter the store together. they made separate purchases where they bought whiskey, beer, cigarettes, and chilli bites. My cashier went to the bathroom and when she returned, she noticed that her phone was missing. We immediately checked the store's cameras

and noticed that it was one of the women who took her phone. We then also noticed that all the women were driving in the same car. I then checked the notes and noticed that they were counterfeit notes. We totalled a loss of over a thousand rand," said

interview with Platinum Bushvelder. Edwin was then able to recall the car's registration number

from the store's camera footage and reported the matter to Thabazimbi SAPS and the community policing forum (CPF).

"I would like to thank SAPS and the CPF for their swift response," added Edwin.

All five suspects were apprehended on the same day near Beestekraal. "The suspects appeared before the Thabazimbi Magistrate's Court on Monday 24 July where their case was

R510 CLAIMS TWO LIVES



Thabazimbi - In a tragic vehicle accident on Saturday 22 July 2023 at approximately 11:00, a motorcyclist and a sedan collided head-on on the R510 outside Thabazimbi, close to Thaba Nkwe Bushveld Inn.

A group of bikers on a breakfast run from Bela-Bela passed through Thabazimbi and were on their way to Vaalwater, planning to later return to Bela-Bela. The biker at the lead and the oncoming vehicle (driver and four passengers), crashed head-on. According to Trauma Rescue industrial manager Hennie Madeley, the motorcyclist was declared dead on the scene. His bike's fuel tank caught fire, which led to an explosion. The vehicle also caught fire, and soon the fire spread through the veld next to the road.

Thaba Fire and Rescue director Kobus Malan said: "When emergency personnel arrived on the scene, they worked quickly to remove the occupants from the burning vehicle."

The driver sustained serious injuries, and sadly later passed away in hospital. The passengers sustained minor wounds.

We extend our heartfelt condolences to the loved ones of the deceased.

CHILD SEXUAL ASSAULT CASE POSTPONED AGAIN

Thabazimbi - The case against the three suspects a man and two women who face charges of sexual assault, child neglect, and assault with the intent to inflict grievous bodily harm was once again postponed on Friday 21 July 2023. The trio will appear in the Limpopo Regional Court on 3 October. The man and the two women were initially arrested on 26 January 2023 after it came to light that a child was sexually assaulted and that two children were brutally assaulted with a cricket bat. On 8 February, the two women were granted bail of R1,000 each while the man was granted bail of R2,000 on the initial charges, but he remained in custody after an additional charge of sexual assault was filed against him. He was released on 13 March 2023 on R2,000 for the first charge, and R500 for the second.



Roadworks in Northam come to a standstill

Thabazimbi - On Wednesday 14 June 2023 TLM started with the resealing and patching of potholes project of internal streets in Northam by attending to some streets in Northam Extension 2 and Northam CBD as well as Thabazimbi Road.

Motorists and residents of the Thabazimbi Local Municipality (TLM) are due for an improved driving experience as the Roads Agency Limpopo (RAL) collaborates with municipalities to implement road infrastructure service delivery. RAL draws from its vast expertise to assist the municipality with maintenance works.

The collaboration indicated that streets such as Chroom, Onyx, Botha, Oppal, Tungsten, Platina, and Mangaan Streets within Northam Township would be upgraded to make them pleasant to drive on. Part of the scope of work on these streets included addressing road issues such as pothole deep patching, milling, and overlay in various streets that have seen considerable deterioration over the years.

But recent rumours have circulated that the project has come to a financial standstill.

Platinum Bushvelder reached out to RAL and received the following feedback on 24 July: "The project is continuing, there had been a system delay in payment which finance managed to resolve. The contractor is back on site and work should continue. The project is ongoing." However, Northam Toyota Butch Anley reported on 26 July that the project still seems to be at a standstill on 1st Street, Botha Street, Middle Street, and Ruby Street. "The tar has been lifted and the streets are bare. With the rain and the traffic, the roads have gotten so bad that a person can't drive there with a normal car. About two weeks ago the municipality said that the contractor would be back on site but there has been no sign of the contractor," said Anley.

Platinum Bushvelder reached out to TLM for comment on 18 July but had not received a response at the time of going to print.


