Thabazimbi - Unhappy community members delivered their threaten existing employment in the region's wildlife economy. It memorandum of demands to the South African National Parks (SANParks) at the gates of Marakele National Park (MNP) on Thursday 6 July 2023. The protest came after SANPark's objection to the opening of an iron ore mine, named Arengo297, which protesters believe will create more job opportunities.

According to extracts from memorandum of demands: "You (SAN-Parks) are fully aware that this is the only mining licence where a black South African woman is a majority stakeholder in the city of Thabazimbi and the province of Limpopo. This should be a milestone and cause for celebration for our younger generation, especially ladies. The aggrieved indigenous communities of Thabazimbi, a city whose identity, livelihood, and history is intertwined with iron ore mining, have been looking forward to the opening of this mine and the new jobs that it will bring to our community. Your objection to this mining application is an outright denial of our community rights and a significant threat to our primary and potential

After the non-violent protest, *Platinum Bushvelder* sought to shed light on the issue by identifying all the parties involved and by requesting clarity on the matter.

Extracts issued by SANParks as a response to the memorandum on 26 July: "SANParks objected to the proposed mine primarily on the basis that the mine would be located on the border with an area that will soon be part of Marakele National Park. This concern was not adequately addressed by the environmental assessment practitioner (EAP) in its response to SANParks comments in this Mineral Resources and Energy (DMRE) for answers but had not regard. SANParks' continued focus and commitment to contribute meaningfully to the Green Economy through its three pillars of sustainable conservation, responsible tourism and socio-economic transformation, and by upholding environmental values for which it has been mandated.

According to the mining company's website, Arengo297 is managed by a chief executive officer (CEO), a president/chairlady (said to be the majority stakeholder), and a chief operating officer (COO). Platinum Bushvelder spoke to the president/chairlady on 17 July. The president/chairlady identified herself as the CEO of the mining company, and according to the chairlady, she could not comprehend why the mine's opening was being hindered, as they had procured a mining license and had followed all the necessary steps and procedures. The president/chairlady also added that the mining company was in no way involved with the protest but said that anyone has the right to peacefully protest. Unfortunately, Platinum Bushvelder could not retrieve proof of the company's mining licence, from this interview, and the following questions remained:

Amandelbult - The Northam police are in the midst of an investigation into the tragic murder of Mr. Frank Alfred Donaldson. His devastated wife found him in an appalling state at their residence within the Tumela village of the Amandelbult Complex. In an immediate response, she notified emergency services and the police, who formally declared Mr. Donaldson deceased at the location of the crime

Limpopo's provincial media relations commander,

colonel Malesela Ledwaba, shared that the fatal incident took place on Wednesday, 26 July 2023, at roughly 15:50.

"The accused, Alfred Donaldson, has been taken into custody for allegedly murdering his father, Frank Alfred Donaldson," colonel Ledwaba announced. "Frank was subjected to numerous stab wounds, leading to extensive injuries."

Reports suggest that Alfred had been residing with his father and stepmother at the time of the incident.

"Following the episode, the suspect purportedly absconded from the crime site, driving away in his stepmother's vehicle. He is also believed to have taken her bank card," Ledwaba continued.

On 27 July, Alfred Donaldson was apprehended and later made his first court appearance on 31 July. Currently, he is detained and his case has been deferred until Monday 7 August for a formal bail hearing.

The investigation is ongoing.


