day when the owner received a call from his employee at about 09:35. The employee reported discovering suspicious footprints on the farm. Upon further investigation, they found that no fences had been cut, but upon reaching the rhino camp, they made a gruesome discovery - two rhinos had been shot and killed, and their horns brutally removed. Authorities are currently conducting a thorough investigation into

the circumstances surrounding the incident. A case docket for rhino poaching has been allocated to the Stock Theft and Endangered Species Unit for further handling.

The police are urging anyone with information that could assist in the the investigating officer, detective warrant officer Jurg Van Heerden, on 082 414 2337 or Crime Stop on 086 001 0111. released on 1 August this year, a total of 231 rhinos were poached in the country between January and June 2023.

Rhino horn continues to be in demand in some eastern countries, where it is used in traditional medicine and as a status symbol to display success and wealth. There is also a belief in its supposed medicinal value, including aphrodisiacal properties, despite a lack of scientific evidence to support these claims.

Dr. Jo Shaw, CEO of Save the Rhino International, emphasised the importance of collaboration in addressing this crisis. "Collaboration across communities, sectors, and borders is critical," said Shaw. "We've got to build strong alliances that can arrest of the suspects to contact proactively deter people from poaching, as well as enable thorough investigations and secure convictions after poaching"

POSTPONEMENT OF CASE INVOLVING CHILD ABUSERS

Thabazimbi - The trial involving the three suspects, a man and two women, who are facing allegations of child sexual assault, child neglect, and assault with the intent to cause serious bodily harm, has once more been postponed until Tuesday 16 January 2024. This follows their appearance before the Thabazimbi Regional Court on 2 November

Initially apprehended on 26 January 2023, the man and the two women were taken into custody when it was revealed that a child had been subjected to sexual assault, and two children had been brutally attacked using a cricket bat.

On 8 February, the two women were granted bail of R1,000 each, while the man was released on bail of R2.000 for the initial charges. However, he remained incarcerated after an additional charge of sexual assault was levied against him. On 13 March 2023, he was granted release on bail of R2,000 for the first charge and R500 for the second charge.

WATERBERG **DISTRICT FLYING SQUAD NABS SUSPECT IN WATER TANKER TRUCK THEFT CASE**

Waterberg members of the Waterberg District Flying Squad apprehended a male suspect for the theft of a water tanker truck on Wednesday, 1st November

The police were conducting crime prevention duties when they received information regarding a white Tata truck that had been stolen in the Lephalale policing area and was reportedly on its way to Mokopane while traveling along the N11 public road.

The members swiftly responded and managed to spot the truck fitting the description, pulling it over. The driver was asked about the legal ownership of the truck, but he failed to provide a satisfactory response and was immediately apprehended on the spot for being in possession of a suspected stolen motor vehicle.

"Johannes Lucas Msiza (39) appeared on 2nd November before the Mokopane Magistrates' Court. His case was postponed to 9th November for further bail applications," said police spokesperson brigadier Hlulani Mashaba.


