# **Arson suspected in** BMW 330 Coupe fire

Thabazimbi - In the early hours of Wednesday, a normal firefighter that we use to fight veld alerted to a distressing incident in Deena Street, Thabazimbi – a vehicle on fire.

The fire, which engulfed a BMW 330 Coupe parked just next to the owner's house, prompted an immediate response from the emergency

Thaba Fire and Rescue acted swiftly, calling upon the Thabazimbi Local Municipality's fire department for assistance. With the knowledge that conventional equipment for such a fire was not at their disposal, the Thaba Fire and Rescue team took an inventive approach to combat the blaze.

Pierre Loots, the director of Thaba Fire and Rescue, detailed the unconventional yet effective method employed to quench the fire. "We used

28 February 2024, Thaba Fire and Rescue was fires," he explained. To enhance their firefighting capabilities, the team ingeniously added Sunlight Liquid to create a foam. This innovative solution aimed to suppress the flames more efficiently by targeting the fumes directly, and not spread to the adjacent home. "It worked," Loots affirmed, showcasing the adaptability and resourcefulness of the team in the face of limited resources. They also used normal fire extinguishers. The community's response to this incident reflects

a remarkable level of resilience and ingenuity.

In an interview with the Platinum Bushvelder newspaper this week, Loots stated, "Currently, it appears to be a case of arson. The investigation



Thabazimbi - A 51-year-old male suspect was apprehended early Tuesday morning, 27 February 2024 in Thabazimbi, for the possession of suspected stolen property.

Following a community tip-off, local authorities conducted a raid on a residential property believed to be storing illegal copper cables. Colonel Malesela Ledwaba detailed the operation: "Upon arrival, our team conducted a thorough search of the premises. Inside a shack on the property, we uncovered bags filled with copper cables valued at approximately R35,000 and weighing 466kg."

The resident, unable to provide lawful ownership for the hoard of copper cables, was taken into custody at the scene.

Lieutenant general Thembi Hadebe, the provincial commissioner of SAPS in Limpopo, lauded the arrest, emphasising its importance in the broader strategy to deter property-related offenses.

The accused made his initial court appearance at the Thabazimbi Magistrates' Court on Wednesday, 28 February 2024, facing charges related to the possession of suspected stolen property.

Authorities urge the public to continue aiding law enforcement by reporting suspicious activities, as collaborative efforts are essential in the ongoing battle against crime.
