MAN SENTENCED TO 30 YEARS FOR RAPING 13-YEAR-OLD GIRL

Thabazimbi - The Thabazimbi Regional Court has handed down a significant prison sentence. On Thursday 14 March 2024, 33-year-old William Kgankge Sekete was sentenced to 30 years in jail after being convicted of raping a 13-year-old girl.

The case stemmed from an incident on 20 January 2022, around 14:30, where Sekete, then a tenant at the victim's home, was found guilty of raping the homeowner's daughter while the homeowner was absent, attending to her work responsibilities. The young girl, in a state of distress, called her mom immediately after the ordeal, prompting her mother to hurry back home. Colonel Malesela Ledwaba reported that the incident was promptly brought to the attention of the police, leading to the registration of a rape case against Sekete at the local station. The case dossier was then assigned to the Family Violence, Child Protection and Sexual Offences Unit in Thabazimbi for further investigation, under the diligent supervision of warrant officer Daniel Joseph Lötter.

Added to his sentence, Sekete was declared unfit to possess a firearm and is mandated to register on the national sexual offenders' register, marking him as a significant risk to public safety.

Lieutenant general Thembi Hadebe, the provincial commissioner in Limpopo, expressed satisfaction with the court's verdict and congratulated warrant officer Lötter.

Warning: Vet and Research Suppliers of Services and Goods

Thabazimbi - Mike Bolhuis issues a serious warning to people who make use of suppliers of services or goods obtained through WhatsApp groups and other social media platforms. While many honest individuals advertise their offerings on these platforms, scammers lurk among them. Unlike traditional advertising platforms, WhatsApp groups and other social platforms do not take responsibility for vetting their advertisers. Therefore, consumers must exercise caution and conduct thorough research before making any payments. Before parting with any money, it's crucial to ensure that the person or company advertising is legitimate. This can be done by searching for their business on Google, requesting and verifying references, and checking online review platforms like Hellopeter for any negative feedback. However, it's essential to scrutinize these reviews, as some may be fake. Recently, a resident of **Thabazimbi** fell victim to such a scam. Mike Bolhuis of Specialized Security Services (SSS) stresses the critical importance of thorough vetting and extensive research before engaging in any financial transaction. Bolhuis shared a concerning incident where a client approached a solar company for panel installation, paying a hefty deposit of R132,733.60 on 18 September 2023. Unfortunately, despite the payment, neither the installation nor a refund has been forthcoming from the company owner. Despite reassurances, the client remains empty-handed. The incident, which took place in Tabazimbi, underscores the

necessity for consumers to exercise caution and due diligence. Bolhuis emphasizes that individuals must take responsibility for safeguarding their finances by ensuring they know whom they are dealing with. Dealing with a local supplier of goods and services will also reduce any risk involved in paying over money. Despite warnings issued over the past year, the prevalence of such incidents is on the rise, highlighting the urgency for increased vigilance among all parties involved in financial transactions.

Fire at Northam **Landfill Site prompts** health concerns



Northam - A fire erupted at the Northam Landfill Site on Tuesday, 12 March 2024, sending clouds of smoke into the air and causing concern among local residents. The cause of the blaze remains under investigation.

Officials from the Thabazimbi Local Municipality responded to the scene to extinguish the fire. Despite their efforts, the smoke, characterised by an unpleasant odour, has raised health alarms in the vicinity, particularly affecting a nearby primary school.

Residents and school authorities have reported cases of respiratory difficulties, attributing these health issues to the dense smoke emanating from the landfill site.

Would you intervene by catching a stray animal to take it to a shelter?

In our community, it's not uncommon to encounter stray animals, particularly dogs, wandering close to roadsides. These animals might be long-time street residents or beloved pets that have accidentally strayed from their homes. Encountering such a situation presents a decision: should you intervene? Would you consider safely stopping to rescue a stray dog and taking it to a local animal welfare organisation, such as the Rustenburg Society for the Prevention of Cruelty to Animals (SPCA) or the Thabazimbi Animal Rescue (TAR)? What do you do in these circumstances?



Did you know; a life sentence in SA is undetermined.

In South Africa, when someone is given a life sentence, it means they could be in jail for their entire life. However, according to the Criminal Law Amendment Act of 1997, sentences vary: the minimum jail time for serious crimes are 25 years for murder, 15 years for rape, and 10 years for robbery before they can ask for parole. Some very rare cases could have a person in jail for 1,000 years with no chance of getting out early. Getting parole isn't guaranteed and depends on if the person behaves well in jail.



Yes! Stray animals are susceptible to a wide array of diseases. They can harbour parasites such as ticks, worms, and fleas, and are at risk of contracting rabies, among other illnesses that might be transmissible to humans or domestic pets. We must all help to prevent this from happening.
