Their journey began late in the afternoon when they were dropped off with their canoe, at the Crocodile River bridge on the outskirts of Thabazimbi. Scheduled to last approximately 3.5 hours, their adventure took

As dusk turned to evening, concern grew among those expecting their return. "At about 19:30, we received a distress call. The women had not arrived at their planned destination," recounted Kobus Malan, a director at Thaba Fire and Rescue. Malan spearheaded the subsequent search and rescue operation that mobilised community members and resources in a race against time.

Efforts intensified under the cloak of darkness, with teams combing the riverbanks and calling out for the missing canoeists. "It was a community-wide effort, with many people coming together to locate the women," Malan added. At approximately 22:00, the search party's perseverance paid off. Far from their intended stopping point, the women came ashore when it became too dark to navigate the waters safely. They sought refuge on foot until they were discovered on a nearby farm, unharmed but undoubtedly shaken by their

"The women accidentally paddled past their exit point on the river. With darkness encroaching, they made the decision to seek safety on land," Malan explained. Their unexpected adventure concluded with them being found by a local farmer, to whom they explained their remarkable story.

This incident serves as a cautionary tale for outdoor enthusiasts and highlights the unpredictability of nature. It also showcases the strength of the Thabazimbi community and its readiness to come together in times of need. Thankfully, this story ended with relief and gratitude, as the women returned home safe, without any injuries.

Thabazimbi - In 'n hartseer wending van gebeure is Johannes van der Bank, gebore op 4 November 1980, tragies oorlede op Sondag 24 Maart 2024. Multi-agency response to head-on collision

Thabazimbi - A severe head-on vehicle collision occurred on Saturday evening, 30 March 2024, causing community emergency services to swiftly unite in response. The accident took place around 20:00 on Warmbadweg, near the Thabazimbi show grounds, prompting an immediate and coordinated effort from local rescue and security teams. According to Edwin Beyers, the crew leader of Thabazimbi Fire and Rescue, the accident involved two vehicles - an Isuzu bakkie and a white Uno travelling in opposite directions. "One of the drivers lost control, leading to a head-on collision," Beyers explained. Supporting Thaba Fire and Rescue were several key local organisations, including Dinare Security, Trauma Rescue, Thabazimbi Local Municipality's Fire Department, Thaba Alarms, RRM Security, the Thabazimbi Police, and the Thabazimbi Traffic Department. The Isuzu was carrying two passengers in

addition to the driver, all of whom sustained minor injuries, including bumps and bruises. The situation for the Uno's driver was more dire, requiring the use of Jaws of Life for extraction before being rushed to the hospital for further treatment. Thaba Fire and Rescue press release extracts

Emergency services respond to serious collision on R510

Thabazimbi – A serious accident took place on Wednesday 27 March 2024 on the R510, about 6 kilometres outside Thabazimbi. "The incident, occurring at around 18:00, involved a collision between a Land Rover Defender and a Toyota Hilux Bakkie," said Thaba Fire and Rescue director Pierre Loots. The Hilux, towing a trailer carrying approximately 30 blesboks, experienced a mishap when the trailer overturned, resulting in the escape of about 3 blesboks.

Thaba Fire and Rescue services were promptly on the scene, alongside units from Trauma Rescue and other ambulance emergency personnel.

The Thabazimbi Local Municipality also provided immediate support to manage the aftermath of the crash. While the exact cause of the accident remains under investigation, the impact of the collision was significant. Two passengers from the Land

Thabazimbi – A fatal accident occurred early on Tuesday morning 2 April 2024 on the R510, about 15 kilometres from Thabazimbi. According to Thaba Fire and Rescue director Pierre

Loots, the collision involved a Toyota Land Cruiser and an interlink truck and happened at around 08:00. Emergency services, including Thaba Fire and Rescue, Thabazimbi and Amandelbult Fire emergency services, Zondereindde Fire emergency services, Trauma Rescue, and the Thabazimbi Local Municipality's Fire department, alongside various emergency medical teams, were quick to respond to the scene of the accident.

The details surrounding the cause of the accident remain unclear. The passenger in the Land Cruiser sustained serious injuries and was rushed to a nearby medical facility for urgent care. Tragically, the driver of the Land Cruiser was pronounced dead at the scene. Reports confirm that the driver of the interlink truck involved in the collision did not sustain any injuries. "Our thoughts are with the families and friends of those involved in this tragic accident," said Loots.

AMPLIFIED AGGRESSION

Thabazimbi - A peaceful morning was disrupted in a Thabazimbi neighbourhood when a silver Toyota bakkie parked in a residential area, blasting loud music, became the centre of a violent altercation on Friday 29 March 2024.

The incident unfolded when a local resident approached the vehicle to politely request that the occupants lower their music and leave the vicinity. Despite the reasonable plea, the bakkie's occupants refused to comply, continuing to disrupt the neighbourhood with their loud music. The situation escalated when the homeowner's husband also attempted to address the noise complaint, only to be met with hostility. A heated exchange quickly turned physical, culminating in a shocking act of violence when one of the bakkie's passengers, reacting aggressively, stabbed the husband. The victim, sustaining three stab wounds, retreated to his property, calling for his family to seek emergency assistance.

The assailants fled the scene shortly after the stabbing, leaving the community in shock over the unprovoked aggression. Local law enforcement has been notified and is currently investigating the incident, urging anyone with information to come forward to assist in the swift apprehension of the individuals involved.
