NO END IN SIGHT

TO SERVICE DELIVERY ISSUES AMIDST POLITICAL UPROAR

Heavily armed members of the South African Police Service stand guard at the Thabazimbi Local Municipality, maintaining order amidst escalating political tensions and service delivery issues.

Thabazimbi – Chaos erupted again at the Thabazimbi Local Municipality (TLM) on Thursday 11 April 2024, forcing the South African Police Service (SAPS) to step in – an all too familiar scene for locals. The ongoing tug-of-war among political factions has only amplified the distress of the residents, leaving them to grapple with a mounting crisis.

Water woes are hardly a shocker in Thabazimbi; the town has faced water supply issues for years on end, thanks to years of financial and other mismanagement handed down the line from one municipal management to the next, including a merry-go-round of political leadership. The situation's made worse by a crumbling water infrastructure that's seen local leaders within the community, taking hands with local stakeholders to patch up bursting pipes, often digging into their own pockets and sacrificing precious time with their families.

Some social media posts suggests that the municipal staff is on a go-slow, though Joshua Motsomane, spokesperson for the TLM, refutes these claims. Talking with *Platinum Bushvelder*, Motsomane explained that while the staff have been paid (directly by the bank), countless service providers haven't seen a penny due to blocked access to the municipal bank accounts. This financial snag has apparently left service vehicles idle and maintenance supplies in short supply.

Amidst the turmoil, prayer groups have started up in the community. People have come to realise that divine intervention is key to restoring some semblance of normality in Thabazimbi.

Thabazimbi – The Thabazimbi community continues to follow a significant court case involving serious Oelofse allegations of child assault. Petrus Oelofse, Jessica Hull, and Ria Oberholzer made another appearance in the Thabazimbi Magistrates’ Court on Wednesday 17 April 2024. Again, the case was postponed to 7 May 2024, because their attorney fell ill. On 30 January 2023, the trio was first presented before the court, facing grave accusations stemming from incidents that deeply concern our community. At the time of their arrest, the trio was operating a well-known local crèche. Petrus was charged with sexual assault and child neglect. In a disturbing revelation, it was alleged that a child was sexually assaulted under his care. Jessica Hull and Ria Oberholzer faced charges of child neglect and assault with the intent to do grievous bodily harm, linked to the brutal assault of two children with a cricket bat. The charges sent shockwaves through the community. The initial arrests were made on 26 January 2023, swiftly after the allegations came to light, leading to multiple court hearings over the past year. The legal process has seen numerous postponements, reflecting the complexity and seriousness of the case. The trio has been released on bail for some time now. The latest court session ended with yet another delay for a pretrial hearing. This next step is crucial for setting the stage for the trial, offering a glimpse into how the case may unfold and its potential impact on the community and the victims involved. As Thabazimbi awaits further developments, the case remains a crucial point of concern, raising questions about child safety and the mechanisms in place to protect the most vulnerable in our community.

What is CANVAS syndrome?

CANVAS is an acronym that stands for Cerebellar Ataxia (CA), Neuropathy (N) and Vestibular Areflexia (VA) Syndrome. CANVAS syndrome is a neurological disorder, which is a problem with the brain, spinal cord and/or nerves.

Symptoms of CANVAS syndrome

People with CANVAS syndrome have symptoms of all three of its components: cerebellar ataxia, neuropathy and vestibular areflexia. Sometimes, people may have symptoms of one or two components for many years before developing symptoms of all three.

Symptoms of cerebellar ataxia may include:

- problems with walking (gait); for many people, this is the first symptom of CANVAS syndrome
- imbalance
- difficulty with coordination, such as trouble picking up objects on the first try
- trouble doing things that need fine motor control, such as writing or eating
- slow, slurred speech (dysarthria)
- rapid, involuntary eye movements (nystagmus)
- trouble swallowing, or feeling as though things get stuck in your throat (dysphagia)

Symptoms of neuropathy may include:

- chronic cough
- muscle weakness, numbness or pain in the hands and feet (peripheral neuropathy)
- pain from things that would not normally cause pain (allodynia)
- abnormal feelings such as burning or electric shock from things that would not normally cause those feelings (dysesthesia)
- trouble swallowing (dysphagia)
- problems with balance
- feeling dizzy or lightheaded when you sit up or stand up (orthostatic hypotension)
- feet that are cooler and sweat less than the rest of the body
- dry mouth or eyes
- constipation
- erectile dysfunction

Symptoms of vestibular areflexia may include:

- loss of balance (also called postural imbalance or loss of postural control)
- unsteady gait (walking or running)
- feeling unstable or dizzy
- in some people, blurry or jumpy vision when the head moves, including when they are walking or running (oscillopsia)
