TRAFFIC CHAOS AT NORTHAM CIRCLE

Residents demand solutions



The wheels on the bus go round and round... or do they?

Northam – The Northam circle, a crucial intersection on the R510, is notorious for its traffic congestion, causing daily frustration for commuters and residents alike. Despite its small-town status, Northam serves as a vital link between Thabazimbi and the North West, hosting a high volume of traffic, especially from the local mines. The intersection also serves as a key pick-up point for taxis, further adding to the congestion.

Suggestions include deploying municipal traffic officials to regulate traffic during peak hours. Despite promises made four years ago, Northam has yet to receive its own municipal traffic officials, leaving residents feeling neglected and frustrated.

Despite the challenges, the community remains resilient and committed to finding solutions. Some residents are proposing ideas to beautify the circle, turning it into a landmark or a community space. This initiative aims to not only improve the visual appeal of the area but also create a more pleasant environment for those stuck in traffic.

As a community that cares deeply for its members, Northam is rallying for change. Residents are urging officials to step up and address the traffic issues promptly. While improvements are underway, residents understand the need for patience but are hopeful for a more efficient and safer traffic flow in the near future.

The traffic situation at the Northam roundabout has reached a critical point, with delays lasting over an hour not uncommon. Residents liken the traffic to that of Johannesburg, noting that even the chickens on the roadside move faster than vehicles during peak times. While there is ongoing road construction to expand to two lanes, the current inconvenience is challenging for residents to endure.

UPDATE ON THABAZIMBI CHILD ASSAULT CASE, THREE DEFENDANTS STILL AWAIT PRE-TRIAL

Thabazimbi – The Thabazimbi community continues to follow a significant court case involving serious allegations of child assault. Petrus Oelofse, Jessica Hull, and Ria Oberholzer made another appearance in the Thabazimbi Magistrates' Court on Tuesday 7 May 2024. Again, the case was postponed to 15 and 20 August 2024, for specific state witnesses.

On 30 January 2023, the trio was first presented before the court, facing grave accusations stemming from incidents that deeply concern our community. At the time of their arrest, the trio was operating a well-known local crèche.

Petrus was charged with sexual assault and child neglect. In a disturbing revelation, it was alleged that a child was sexually assaulted under his care. Jessica Hull and Ria Oberholzer faced charges of child neglect and assault with the intent to do grievous bodily harm, linked to the brutal assault of two children with a cricket bat. The charges sent shockwaves through the community.

The initial arrests were made on 26 January 2023, swiftly after the allegations came to light, leading to multiple court hearings thereafter. The legal process has seen numerous postponements, reflecting the complexity and seriousness of the case.

The trio has been released on bail for some time now.

The latest court session ended with yet another delay for a pretrial hearing. As Thabazimbi awaits further developments, the case remains a crucial point of concern, raising questions about child safety and the mechanisms in place to protect the most vulnerable in our community.

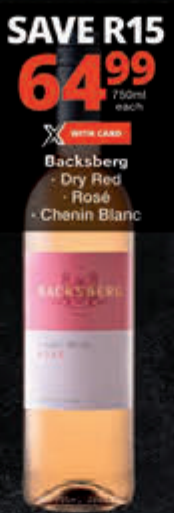

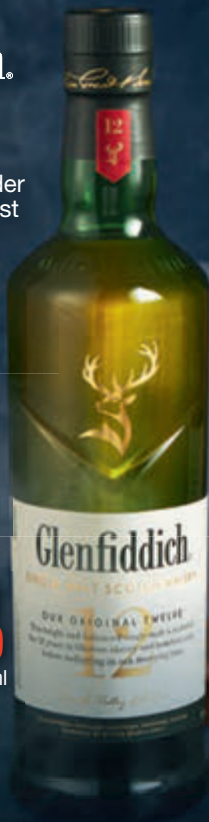

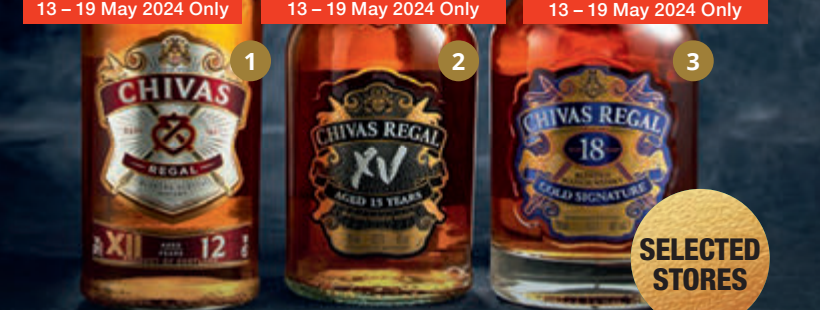
