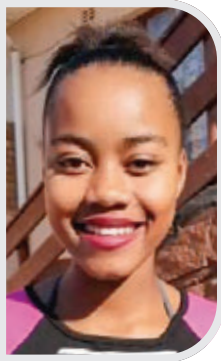


In loving memory of Sumeya Dyushe
