Among heaps of garbage, a life that had barely begun was thrown away - a moment that has not only shaken the community but raised urgent questions about care, support, and the silent battles women face. Local police are currently investigating the matter, and further updates are expected. But behind the headlines lies a deeper issue - one that child protection institutions, healthcare workers, and social workers say must be addressed with urgency and heart.

#### **Heartbreak and Hidden Struggles**

According to organisations like SAVF-Thabazimbi Family Care, this case of abandonment highlights just how many women in underdeveloped communities remain unaware of the support services available to them. Whether due to fear, stigma, or lack of information, too many feel forced into silence - or into actions that they would never choose under different circumstances.

In South Africa, abortion is legal under specific conditions as outlined in the Choice on Termination of Pregnancy Act of 1996.

Northam - In a devastating discovery, a foetus was found discarded It allows for termination up to 12 weeks on request, and up to 20 weeks under particular medical, emotional, or socio-economic grounds. After 20 weeks, it is allowed only in extreme cases.

These services exist not to promote abortion, but to offer women a safe, confidential, and dignified choice in extremely difficult

#### Stigma, Silence, and the Fear of Being Judged

Too often, the decision to seek help is blocked by fear — of being called immoral, of being disowned by family, or of being rejected by their community. In many households, cultural and religious beliefs reinforce the silence

Adoption, another legal and supportive option, remains highly underutilised due to its own social stigma. Yet it provides a life-saving alternative for mothers who are unable to raise their children, and hope for families who cannot conceive. Under the Children's Act, adoption is intended to offer children a safe, nurturing, permanent home — and mothers a dignified path forward.

### **MOB JUSTICE CLAIMS TWO LIVES**

commissioner, lieutenant general Thembi Hadebe, has condemned an incident of mob justice that left two men dead in the Apiesdoring informal settlement on Thursday, 17 April 2025. Police were called to the scene at around 14:10, where they discovered a man lying in the street with multiple open wounds. He was declared dead on arrival by emergency medical services. While still on the scene, police received reports that community members were chasing and assaulting another man — allegedly responsible

and managed to rescue the second man, who was transported to hospital. However, he later succumbed to his injuries. Colonel Malesela Ledwaba confirmed that the motive behind the stabbing and subsequent mob assault is still under investigation. Lieutenant general Hadebe strongly condemned the actions of the community.
